

As we continue with our work on Ease of Doing Business (EODB) in the country, the Anti-Red Tape Authority (ARTA) has launched the country's first ever **Philippine Good Regulatory Principles (PGRP)** last July 1, 2021. The PGRP is a set of ten (10) core principles to provide guidance to government agencies on how they should regulate, and for businesses and other regulated entities on what to expect from these government regulators.

Moreover, the PGRP is an important component of the National Policy on Regulatory Management System (NPRMS) and shall also serve as guidance for regulators on how to develop and review regulations, in compliance with the provisions of the EODB Law and the NPRMS.

As part of the ongoing information dissemination campaign on this new initiative, the Authority is organizing a series of webinars for our development partners and stakeholders via the Zoom Platform. This is also part of a technical assistance program in partnership with the UK Department for Business, Energy, and Industrial Strategy (BEIS) and the UK Foreign, Commonwealth and Development Office (FCDO).
