We are forwarding to your office the copy of the Department of Budget and Management (DBM) letter dated 4 October 2021 regarding the FY 2021 1st Semester Agency Performance Review (APR) and Evaluation Report on physical, financial and income performance of our department.

Based on the DBM's findings on our physical performance, the department was able to accomplish most of the set targets for the semester of FY 2021 based on the submitted Physical Plan, consistent with the Performance Informed Budget (PIB). However, it was noted that some output indicators are lower than the target accomplish rates.

With regards to our financial performance, our department collectively posted an obligation rate of 52.58% and disbursement rate of 67.65% as of June 30, 2021. The financial performance of DENR major programs are shown below:

a) Obligations Budget Utilization Rate:

Highest - National Greening Program - 83.01% Lowest - Manila Bay Rehabilitation Program - 17.22%

b) Disbursements Budget Utilization Rate:

Highest - Clean Water Program - 84.07%

Lowest - National Greening Program – 38.24%

Further, the actual combined income of the DENR agencies is P1.921 Billion against a full-year target of P2.123 Billion or an equivalent rate of **90.50%**. It is also noted that MGB exceeded its FY 2021 annual revenue target by 50.88%.

In view of this, may we request your office's support to expedite the following DBM's recommendation to improve the agency's performance and utilization rate:

- 1) To re-strategize for the implementation of projects hampered by pandemic;
- 2) To assess the cause of the low rate of obligations and identify areas which may hamper the rate of disbursements;
- 3) To closely monitor the performance of the major programs to ensure that any problems in the implementation may be addressed immediately;

- 4) Implement early procurement activities short of award upon issuance of National Expenditure Program;
- 5) To factor in the "new normal" scenario in program/project implementation and foster closer coordination with stakeholders on the delivery of services and/or equipment during ECQ/lockdowns to ensure that targets and deliverables are achieved;
- 6) Strengthen linkages between planning, budgeting and accounting divisions to achieve optimum fund utilization;
- 7) Ensure the accurate encoding of all required Budget and Financial Accountability Reports (BFARs) in the Unified Reporting System (URS).
- 8) Ensure that the performance indicators and targets reported in the BAR No. 1 Quarterly Physical Report of Operation consistent with the performance indicators and targets under Volume II of the RA No. 11518 and FY 2021 GAA; and
- 9) Monthly Updating of the Personal Services Itemization and Plantilla of Personnel (PSIPOP) in the web-based application system.

May we request your office's support in addressing the concerns related to implementation of plans and performance of offices particularly the <u>Items No. 1, 3 and 5</u> as mentioned above.

Dear Secretary Cimatu:

Pursuant to DBM Circular Letter No. 2018-13 (Guidelines for the Conduct of Agency Performance Reviews (APRs) and Evaluation Thereof Effective FY 2018 and Onwards), please be informed that we have completed the mid-year review of your Department's physical, financial and income performance, the results of which are presented below:

On Physical Performance:

The Department was able to accomplish most of the set targets for the 1st semester of FY 2021 based on the submitted BED 2 — Physical Plan, consistent with the Performance Informed Budget (PIB). However, we noted lower than target accomplishment rates for some output indicators:

On Financial Performance:

Insofar as financial performance is concerned, the DENR agencies collectively posted an obligation rate of **52.58%** (obligations vs. allotment released) and a slightly higher disbursement rate of **67.65%** (disbursements vs. obligations) as of June 30, 2021

However, the obligation BUR, if computed against the Financial Plan (BED 1) is **89.26%**, and the disbursement BUR if computed against the Monthly Disbursement Program (BED 3) is **69.60%**.

A review of the performance of DENR's major programs under the Office of the Secretary and the Environmental Management Bureau (EMB) disclosed that as of midyear, obligations BUR ranged from a low of 17.22% (Manila Bay Rehabilitation Program) to a high of 83.01% (National Greening Program). On the other hand, if we consider the disbursements BUR, NGP registered a 38.24% rate while the Clean Water Program of the EMB registered the highest BUR at 84.07%.

On Income Performance:

As of June 30, 2021, the actual combined income of the DENR agencies reached **P1.921 Billion** against a full-year target of **P2.123 Billion**, or an accomplishment rate of **90.50%**, details as follows:

It is encouraging to note that the MGB has already exceeded its FY 2021 annual revenue target by 50.88%.

Recommendations:

- On the attainment of physical targets, the DENR may have to re-strategize for the implementation of projects hampered by the pandemic during the first semester, particularly OSEC and the PCSDS.
- With regard to financial performance, given the collective obligations BUR of 52.58%, (BURs of the EMB and the MGB are yet to reach the 50% mark), there may be a need for the agencies to assess the cause of the low rate of obligations and to address these as needed. We noted however that the BURs are significantly higher if we compare obligations against the First Semester Financial Plans. Similarly, the agencies may need to identify areas which are hampering the rate of disbursements considering the collective rate of 67%.
- The performance of major programs has to be closely monitored to ensure that any problems in implementation may be addressed immediately;

- We reiterate policies on early procurement activities short of award upon the issuance of the National Expenditure Program, pursuant to Sections 7.6 and 20.1 of the Revised Implementing Rules and Regulations of RA 9184 (Government Procurement Reform Act);
- To factor in the "new normal" scenario in program/project implementation and foster closer coordination with stakeholders on the delivery of services and/or equipment during ECQ/lockdowns to ensure that targets and deliverables are achieved;
- Strengthen linkages between planning, budgeting, and accounting divisions to achieve optimum fund utilization;
- Ensure the accurate encoding of all required Budget and Financial Accountability Reports (BFARs) through the Unified Reporting System (URS) With regard to the submission of BAR No. 1 - Quarterly Physical Report of Operation, the performance indicators and targets reported should be consistent with the performance indicators and targets under Volume II of the Republic Act (RA) No. 11518, FY 2021 General Appropriation Act (GAA); and
- Monthly updating of the Personal Services Itemization and Plantilla of Personnel (PSIPOP) in the web-based application system pursuant to National Budget Circular No. 549 dated October 21, 2013 to avoid deficiencies in the annual appropriations for Personnel Services.

The government recognizes the efforts of the DENR in delivering its commitments reflected in the performance indicators under Vol. II of RA No. 11518, FY 2021 GAA.

The DBM shall be pleased to provide any clarification/additional information on the findings contained in this letter as needed. Thank you.
