In preparation for the 8th Asia Pacific Forum on Sustainable Development (APFSD) to be held during 23-26 March 2021 in a hybrid mode in Bangkok and online, we welcome your views on progress towards achieving the Sustainable Development Goals (SDGs) in Asia and the Pacific.

The theme of the 8th APFSD is *"Sustainable and resilient recovery from the COVID-19 pandemic in Asia and the Pacific"*. In line with discussions at the 2021 High-Level Political Forum (HLPF), the 8th APFSD will focus on 7 SDGs:) /

SDG 1 (No poverty); SDG 2 (Zero Hunger); SDG 3 (Good health and well-being); SDG 8 (Decent work and economic growth); SDG 10 (Reduced Inequalities); SDG 12 (Responsible consumption and production); SDG 13 (Climate Action); SDG 16 (Peace and justice); and SDG 17 (Partnerships for the goals).

A special session, co-led by FAO and WFP, is dedicated to Goal SDG 2 (Zero Hunger). The discussion will also include the SDG2 goal profile developed using a combination of statistical data and analysis produced by UN Partner Agencies and the outcome of this multi-stakeholder survey. Moreover, this year's survey will include country-specific information on the COVID 19 pandemic impact on the SDG implementation.
