Annex 1:

The World Bank Advisory Services and Analytics (ASA) on Indigenous Peoples in the Philippines (P177409)

The World Bank is preparing the first-ever Analytical Report focused exclusively on Indigenous Peoples (IPs) issues in the Philippines. The report is led by World Bank Task Team Leaders Carlos Tomas Perez Brito (Senior Social Development Specialist) and Nadia Belhaj Hassine Belghith (Senior Economist).

Strategic Context: Available evidence from the few available data and studies suggests that IPs lag behind the general population in many socioeconomic factors (education and nutrition for example). However, little research has been done examining the disparities among and within ethnic groups in the country. The absence or under-representation of IP-specific data and information in official national surveys and administrative data has also prevented an accurate understanding of their socio-demographic profile and the extent of the challenges and inequalities IPs face. Among multiple challenges, the governance of ancestral domains and territories is one of the top priorities among indigenous leaders and communities that contribute to the IP identity, subsistence, and inclusion.

Objective: The development objective of this analytical report is to inform policy, operations, and research agenda for the promotion of social inclusion strategies targeted at IPs in the Philippines.

Activities: This will be done through a series of activities, including: (a) mapping IPs' data in government central and sectoral databases and information systems (including ethnicity variables, dataset, and surveys), and sectoral policies/ regulations specific to IPs (education, health, agriculture, environment, etc.); (b) quantitative and qualitative poverty and inequality analysis using existing data and information from population census, surveys, administrative data and interviews; and (c) spatial multicriteria analysis of ancestral domains and indigenous territories with publicly available information.

Annex 2:

Key Interview Questions:

- 1. What are the available Indigenous Peoples (IP)-related information (or ethnicity, language, geographical variables) in the form of official surveys or administrative data in your agency (preferably in machine-readable formats)? Are the data published, and could the micro data be accessed for further analysis and survey forms/questionnaires be shared with the World Bank (i.e., data on IPs that received assistance through the DENR's programs; data/ shapefiles on illegal logging hotspots, tenurial instruments and management agreements that may be relevant to IPs)?
- 2. What are government policies, regulations, and other ordinances relating to IPs in your agency? Could these legal, administrative and policy instruments and documentations be shared with the World Bank?
- 3. What are the key challenges the agency face in relation to IPs, including their inclusion, data collection and targeting, etc.?
- 4. Are there ways that the activities of the World Bank's analytical report can contribute towards your agency's work, particularly in reaching the IPs more effectively?
- 5. Any general comments/feedback on the activities of the analytical study, or areas of possible collaboration and support?
