SUBMISSION OF PROOF OF POSTING OF THE

UPDATED/LATEST CITIZEN'S CHARTER FOR CY 2022

Pursuant to Rule IV of the Joint CSC-ARTA-DTI Memorandum Circular (MC) 2019-001 or the Implementing Rules and Regulations (IRR) of Republic Act (RA) 11032 otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act (EODB) of 2018 and Item 3.3. of Anti-Red Tape (ARTA) MC 2019-002-A or the Supplemental Guidelines in the Implementation of Citizen's Charter (CC) on posting of the latest/updated CCs at the main entrance of or most conspicuous place in your office, you are required to comply with the following requirements:

- 1. Make available to the public your updated/latest Citizen's Charter to include:
 - a. A handbook displayed at the Public Assistance Desk of Offices;
 - b. Posters containing the <u>applicable processes</u> posted at the main entrance of or most conspicuous places in your Offices. A sample is provided in Annex "A" of this memorandum. It is also encouraged that the display of Citizen's Charter be made through the use of interactive kiosks, television and/or computer screens; and
 - c. Link or page in your Bureau Website.
- 2. Consolidate the necessary documentary requirements and submitted using the template provided in Annex "B". <u>Submission shall be in a single Portable Document Format (PDF) file</u>; and
- 3. Submit directly to this Office, through the Sub-CART on CC Compliance and Monitoring with email address at denr.arta@gmail.com and not to the ARTA, on or before 19 April 2022, your proof of compliance with the aforementioned requirements, in the form of electronic copies (e-copies) in PDF file and not in hard or printed copies.





The pages can be flipped to show the Citizen's Charter process flows.









1) Panoramic View of the Citizen's Charter posters and/or Public Assistance Desk






2) Mandate, Vision, Mission and Service Pledge




