SUBJECT: AUTHORIZING THE CONDUCT OF CONFERENCE TO RESOLVE THE CONFLICTING FINDINGS ON FOREST RESERVE (FR) 142 AND THE LAND CLASSIFICATION (LC) MAP 1024
