This pertains to our proposed Workshop re: Trade in Environmental Goods and Services which will be conducted later this year.

The workshop aims to:

- Provide an introductory knowledge to technical/legal representatives from the Bureaus and the concerned Offices on scheduling "market access" commitments for trade in services negotiations;
- 2) Provide updates on trade engagements in the Philippines, including environmental goods and services commitments under the Regional Comprehensive Economic Partnership (RCEP) Agreement, the World Trade Organization (WTO) Agreement on Trade Facilitation, and other international and regional trade agreements;

- 4) Bio-Circular-Green Economy [FMB, BMB, EMB, CCS]
- 5) Plastics Pollution and Environmentally Sustainable Plastics [EMB]
- 6) European Union's Green Deal: carbon border adjustment mechanism (CBAM) [EMB, CCS]; and EU and UK Due Diligence (FMB)
