I wish to transmit the attached invitation from the WTO Secretariat for the Philippines to nominate up to three (3) candidates to participate in the WTO Funded Internship Programmes namely – the Netherlands Trainee Programme (NTP) and the French-Irish Mission Internship Programme (FIMIP).

The programs are intended for mid-level public officials, with a minimum of five (5) years of working experience in WTO issues. NTP targets LDCs and SVEs, while FIMIP application is open for LDCs and other developing countries with preference to be given to those with lower per capita GNP and least number of staff in Geneva. Philippines may be interested to submit applications to both programs noting that priority will be given to LDCs.

A maximum of 15 interns will be accepted for the NTP and will be based in the WTO, while a maximum of 20 interns will be accepted for FIMIP and will be based in their respective Missions in Geneva. Internship duration in both programs cannot exceed 10 months. Details on the application criteria and requirements for both programmes may be found in the attached Annex.

Candidates have until 31 August 2022 to complete and submit their online application form at: <a href="https://wto.formstack.com/forms/internshipprogrammes2023">https://wto.formstack.com/forms/internshipprogrammes2023</a>.

Application should include a complete curriculum vitae (CV), a letter of motivation, specific indications of the tasks that the candidates would like to perform, a short biography of 10 lines maximum, a letter of support from the TCWM Chair (as national nominating authority), a letter of support from the Philippine Mission to the WTO as host.
