COOPERATION AGENCY

This pertains to the attached invitation of the Technical Education and Skills Development Authority (TESDA), which was received by this office on 01 August 2022, inviting DENR to participate in the Singapore Cooperation Programme (SCP) foreign training program entitled "Clean Energy and Emission Reduction" on 17-21 October 2022, online through Zoom application.

The goal of the training course is to engage participants in the formulation of energy solutions to mitigate climate change issues. Participants will also gain understanding of the various types of clean and renewable sources of energy and the related technical principles.

In this regard, please nominate one (1) candidate with the following qualifications:

- 1. Mid- to senior-level government official involved in policymaking for climate change, environmental sustainability and energy solutions;
- 2. Minimum of five (5) years work experience;
- 3. Between the age of twenty-five (25) to fifty-five (55) years old.
- 4. Proficient in written and spoken English;
- 5. In good physical and mental health; and
- 6. Able to attend all of the synchronous e-learning sessions.

The nominee shall submit the following requirements to the Human Resource and Development Service Training and Development Division (HRDS-TDD) (link: https://hrds-tdd.acent.gov.ph) not later than 15 August 2022:

1. Memorandum addressed to the Chair of the Human Resource Development Committee (HRDC), attention to HRDC Secretariat, with justification on how the training will benefit the nominee and project's relevance to the organization needs, to be endorsed by the Head of Office;

- 2. Resolution from the HRDC counterpart (Regional/Bureau/Attached Agency) nominating the applicant;
- 3. Invitation letter disseminated by the DENR/Sponsoring agency;
- 4. Service Record (at least two (2) years as a permanent employee);
- 5. Certificate of no pending administrative or criminal case;
- 6. Certification of actual duties and responsibilities (including past involvement) relevant to the program signed by immediate superior;
- 7. Certification from the Director supervising human resources/Assistant Regional Director for Management Services/Assistant Director Regional/Bureau/Attached Agency) stating:
 - a) That the applicant has at least a very satisfactory performance rating for two (2) immediate rating periods;
 - b) That the applicant has no pending scholarship nomination;
 - c) That the applicant has not been a delinquent scholar from a previous scholarship grant;
 - d) That the applicant has submitted all required reports from previous foreign travels;
 - e) That the applicant has rendered the required service obligation for a scholarship previously enjoyed; and
 - f) That the applicant shall not withdraw from the nomination and once accepted shall complete the course and not be allowed to cancel or terminate the scholarship/training without justifiable reason and without giving prior notice to and getting approval from the donor institution, TESDA, and his agency.
- 8. Original copy of the updated Personal Data Sheet (with list of in-service trainings and seminars attended) and 2x2 photo (hard and soft copies);
- 9. Self-certification for official travel history; and,
- 10. Individual Development Plan (IDP);

The Human Resource Development Committee (HRDC) will conduct the screening and selection of candidates for the learning course. The HRDS-TDD shall submit to TESDA the required documents of participants endorsed by the HRDC. The deadline for submission of nomination and documentary requirements to TESDA is on 26 August 2022, with an interview through Google Meet scheduled on 08 September 2022.

The final decision for participation in the training course will be decided by SCP and the Government of Singapore. The Singapore Ministry of Foreign Affairs shall inform the applicant and TESDA the results of the application for the training course.

No cost shall be borne by the office relative to the participation of the nominee in the training course.

Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people, Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations.

In 1992, the Singapore Cooperation Programme (SCP) was established to bring together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes were increased to share Singapore's development experience with other developing countries.

To date, over 137,000 officials from more than 180 countries and territories have participated in our courses and study visits. The SCP is managed by the Technical Cooperation Directorate of the Ministry of Foreign Affairs, Singapore.

Singapore Environment Institute

The Singapore Environment Institute (SEI) is the training and knowledge division of the National Environment Agency (NEA) of Singapore. It is responsible for the delivery of in-house technical training and building of environmental knowledge among staff to build a relevant, resourceful, and resilient NEA workplace.

Through its industry programmes with institutes of higher learning, SEI also supports capability building and Continuing Education and Training (CET) needs within the local environmental services industry. In addition, the Institute actively supports the capacity building needs of identified countries via training programmes and workshops.

Climate Action Package

This course is part of Singapore's Climate Action Package, a suite of courses launched in 2018 to support the efforts of other developing countries in building climate resilience and achieving their climate pledges.





Course Objectives

This course will focus on Singapore's multi-agency engagement in formulating energy solutions to climate change, achieving a better appreciation of the issues surrounding climate change and the importance of collective mitigating actions taken on a global scale. Participants will also gain an understanding of the types of clean and renewable sources of energy and the related technical principles.

Synopsis

Topics to be covered include:

- Introduction to clean energy resources and technologies
- Energy and climate security
- Sustainable and clean energy governance issues
- Energy efficiency and conservation
- Renewable energy and Clean Development Mechanism
- Applications of clean energy

Methodology

This course will be delivered for up to <u>30 participants</u> and conducted in English through *synchronous e-Learning* ('live' e-learning sessions). There will be Q&A sessions and facilitated group discussions during the 'live' sessions on Zoom.

Duration

The course will be held over 5 days from 17 to 21 October 2022, 1400h to 1730h (Singapore time; GMT/UTC+08:00) daily. [Note: Session timings may be subject to change.] Participants will receive the detailed programme schedule once it is finalised.

Prior to course commencement, SEI will conduct a compulsory onboarding session to brief all participants on the rules of engagement (break time, attendance, punctuality, recording, Q&A).

More details on the programme schedule will be provided to successful applicants closer to the start of course.

- Mid- to senior-level government officials involved in policymaking for climate change, environmental sustainability and energy solutions:
- Able to attend all the synchronous e-learning sessions. They will require an internet-enabled device with Zoom installed, webcam, microphone and audio:
- Nominated by their respective Governments;
- · Proficient in written and spoken English; and
- In good health.

Terms of Award

The course is sponsored by the Government of Singapore under the Singapore Cooperation Programme Training Award.
