#### PROCLAMATION NO. 1403

DESIGNATING A PARCEL OF LAND LOCATED IN BARANGAY BAGUMBAYAN, QUEZON CITY, FOR INCLUSION INTO THE EXISTING EASTWOOD CITY CYBERPARK INFORMATION TECHNOLOGY PARK, PURSUANT TO REPUBLIC ACT NO. 7916, AS AMENDED

Pursuant to the powers vested in me under Republic Act (RA) No. 7916, or the "Special Economic Zone Act of 1995," as amended, and upon the recommendation of the Board of Directors of the Philippine Economic Zone Authority (PEZA), I, RODRIGO ROA DUTERTE, President of the Republic of the Philippines, do hereby designate a parcel of land located in Barangay Bagumbayan, Quezon City for inclusion into the existing Eastwood City CyberPark Information Technology Park, subject to the provisions of RA No. 7916, as amended, its Implementing Rules and Regulations, PEZA Board of Directors Resolution No. 00-411 (s. 2000), as amended by Resolution No. 04-295 (s. 2004), and Resolution No. 17-470 (s. 2017), with an area of Four Thousand Twelve square meters (4,012 m²), more or less, as defined by the following technical description:

# Lot 16-B (LRC) Psd-297560 Transfer Certificate of Title No. 004-2013013487

A parcel of land (Lot 16-B of the subdivision plan [LRC] Psd-297560, being a portion of Lot 16, Block 2, Pcs-04-000121, LRC [GLRO] Rec. Nos. 699, 875 & 917), situated in Barangay Bagumbayan, Quezon City, Metro Manila, Island of Luzon.

Bounded on the NE., point 3 to 4 by Lot 15, Block 2, Pcs-04-000121; on the SE., and NE., points 4 to 8 & 8 to 1 by Sidewalk Lot 7, Pcs-04-000121; on the SW., point 1 to 2 by Lot 16-A of the subdivision plan; and on the NW., point 2 to 3 by Lot 49-C-2-A-3, Psd-3243.
