

HOUSE BILL NO. 2657



Introduced by Rep. Sittle Aminah Q. Dimaporo and Rep. Mohamad Khalid Q. Dimaporo

EXPLANATORY NOTE

This bill seeks to establish an arboretum in the campus of the Mindanao State University-Lanao del Norte Agricultural College in Barangay Ramain, Municipality of Sultan Naga Dimaporo to be known as the MSU-LNAC Arboretum.

An arboretum is an area devoted to specimen planting of woody plants which are either trees or shrubs. Distinct from a forest or park, it is in a sense an outdoor museum of trees. It is a place where many varieties of trees and shrubs are grown for research, educational, and ornamental purposes where trees and other woody plants are cultivated for exhibition.

An arboretum plays an important role in the lives of many people and is a valuable environmental, educational, recreational, and cultural resource for the country. It plays an important role in the area of conservation and preservation of endangered species of trees where they can be protected and propagated to preserve the biological diversity of planet Earth.

Trees help us address climate change by reducing the amount of greenhouse gases in the atmosphere. They do this by absorbing carbon dioxide (CO_2) , using the carbon (C) to produce sugar for tree growth and releasing the oxygen (O_2) back in the air. As trees grow, they store carbon in their leaves. Planting more trees surely mitigate the effects of climate change – as long as the right trees are planted in the right place. An arboretum is such one right place.

Many services that an arboretum performs for the public at large are too well known to require elaboration. So also is the educational importance of an arboretum attached to a college or university. Perhaps the most important arboretum function from the academe point of view is to provide an outdoor laboratory for scientific studies by faculty, students and residents in dendrology, phenology, botany, environmental studies, photography and other related fields of study. The arboretum will serve as an educational resource for environmental stewardship, the history of the province, the study of trees and other woody plants, and a place of learning and respite for the people of Lanao del Norte. Hence, this bill.

In view of the importance of protecting and conserving endangered tree species and other woody plants, and having a clean and healthy environment, approval of this measure is earnestly requested.

HOUSE BILL NO. 263

Introduced by Rep. Sittle Aminah Q. Dimaporo and Rep. Mohamad Khulid Q. Dimaporo

AN ACT ESTABLISHING THE MINDANAO STATE UNIVERSITY-LANAO DEL NORTE AGRICULTURAL COLLEGE ARBORETUM IN BARANGAY RAMAIN, MUNICIPALITY OF SULTAN NAGA DIMAPORO AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby established an arboretum of one hundred (100) hectares within the site reserved for the Mindanao State University-Lanao del Norte Agricultural College (MSU-LNAC) in Barangay Ramain, Municipality of Sultan Naga Dimaporo, Province of Lanao del Norte to be known as the MSU-LNAC Arboretum.

For purposes of this Act, Arboretum refers to a reserved area which is essentially for a well-grown and representative collection of trees or shrubs species planted and maintained for the purpose of scientific study and maintaining a convenient source of seed and herbarium materials.

SECTION 2. The MSU-LNAC Arboretum shall have the following purposes:

a) To aid in the study and teaching of dendrology, phenology, botany, biology, and other related fields of study by being utilized as an outdoor laboratory by faculty and students of nearby schools;

- b) To be sanctuary for the preservation and conservation of genetic resources of trees and shrubs, and as a model for environmentally sound landscape management;
- c) To be a nursery within which the best species of indigenous woody plants can be propagated and where new species can be introduced;
- d) To be a place for recreation whre people can renew their affinity with nature and thus be more conscious of their responsibility as stewards and guardians of the natural environment; and
- e) To serve as the habitat for a variety of amphibians, reptiles, birds, small mammals, and other wildlife in the area.

SECTION 3. The layout and design of the arboretum shall conform to its objectives and to the following consideration:

- a) The trees should be planted in rows following the contour of the land area;
- b) At least five (5) replicates of each species should be planted to ensure the security of the species;
- c) Each tree species should be numbered, labelled and tagged with scientific name, common or local name, and the date and place of collection. In case of mortality, the species should be replanted with the appropriate species should be replanted.

SECTION 4. To ensure the growth of the species to be planted:

a) Each tree species should be of high quality materials, the selection of which should be made at least twelve (12) months prior to planting, in

- consultation with the nearest office of the Department of Environment and Natural Resources (DENR).
- b) Proper site preparation should be done prior to planting, to include brushing/slashing, staking, digging of hole, plowing and/or cultivation.
- c). Planting should be done at the onset of the rainy season.

SECTION 5. The Arboretum shall be placed under the overall management and supervision of the DENR. The DENR Secretary shall be appoint a Superintendent of the Arboretum who, together with a staff to be selected by the DENR from among its staff, shall ensure the proper management of the Arboretum.

SECTION 6. A Monitoring Committee is hereby created to track the development and oversee the operation of the arboretum. It shall be composed of the following:

- 1) DENR Secretary or a duly designated representative as Chairperson:
- 2) The Provincial Governor of the Province of Lanao del Norte or his representative as Co-Chairperson;
- 3) Mayor of the Municipality of Sultan Naga Dimaporo as Vice-Chairperson;
- 4) President of the League of Municipal Mayors of Lanao del Norte or the Vice-President thereof if the Mayor of Sultan Naga Dimaporo is the President of the League, as member;
 - 5) Chancellor or Head of the MSU-LNAC as member; and
- 6) One (1) member to be appointed by the DENR Secretary from among three (3) recommendees of the Provincial Governor.

SECTION 7. All grants, bequests, endowments, donations, and contributions made to the MSU for the development and improvement of the arboretum shall be administered solely for the benefit of the arboretum in accordance with the instructions of the donor, or in default thereof, of the MSU-LNAC.

SECTION 8. The amount necessary to implement initially the provisions of this Act shall included in the annual General Appropriations Act.

SECTION 9. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
