

The event will be simultaneous with the commemoration of the Philippine Environmental Planning Day, the first ever in-person celebration by the virtue of Presidential Proclamation 847 issued during the incumbency of President Rodrigo Roa Duterte. This is also simultaneous with the World Town Planning Day to be participated by more than 30 countries around the globe.

Interested and qualified employees and those officials with SG 24 and up from the regions and bureaus shall submit their duly accomplished Endorsement Form signed by their respective Service Director or immediate supervisor to the Training and Development Division, HRDS **at least two (2) weeks prior to the activity**, for the preparation of necessary Special Order. **Interested employees with SG 23 and below from the regions and bureaus** shall submit to their respective HR Unit/Section for preparation of Regional Special Order.

The investment cost for this event is amounting to Six Thousand Pesos (PHP 6,000.00) to be paid to PIEP, subject to the usual accounting and auditing rules and regulations. Since attendance to the training is exempted from the provision of Administrative Order No. 103 dated 31 August 2004, the registration fee shall be charged against their respective funds. 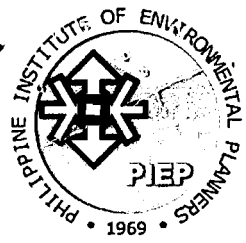


Registration Fee is P 6,000.00 per participant to defray expenses for the venue, food and materials. This however do not include accommodations.

We look forward for your support and favorable response in advancing the environmental planning for the **Development of Sustainable Communities and Ecosystems**.


