



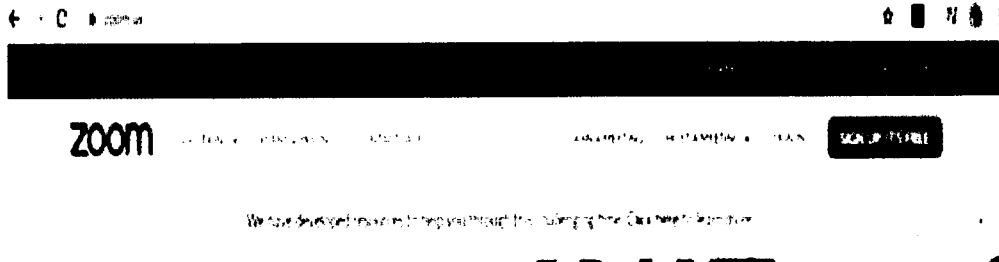

### Google Forms

- Each participant must access the zoom link using a device with a webcam or front camera and be connected to the internet connection. It is advisable to use earphones with a microphone for a more interactive experience. For first-time users, familiarize yourself with the website <https://zoom.us/> or watch this video <https://www.youtube.com/watch?v=fGbpwZNW3oI>.
- Download the Zoom application and click JOIN A MEETING. The Meeting ID and password will be sent to your e-mail or through Messenger group chat (if provided by TDD-HRDS).  
(You may opt to download the zoom application, or you can join from the browser.)



- All learners present during the lecture must wear the prescribed DENR uniform or appropriate office attire.
- Close all background applications that have no connection with the lecture.
- Rename your zoom user with this format: Office\_Name
- Mute your microphone upon signing in and during the webinar so as not to distract the speaker.
