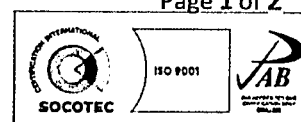
Action Requested. For the members of the NIC-Executive Technical Board to assist in disseminating the call for nomination of the Executive Members to the NIC.

Approved via the NIC Resolution No. 03, Series of 2022, the NIC Memorandum Circular No. 01, Series of 2022, *Guidelines on the Criteria and Selection Process for the Executive Members of the National Innovation Council (NIC)*, was published last 19 September 2022 in the Official Gazette Volume 118 No. 38. It shall take effect 15 days after its publication, which is 5 October 2022.

To fast-track and ensure a wide reach for the nominations, the NIC Secretariat requests member agencies to disseminate the information and promotion materials on the call for nomination in their websites, email networks, social media, and other platforms the members may deem appropriate. The call for nominations will start on 5 October 2022 and submissions will be accepted until 31 October 2022.

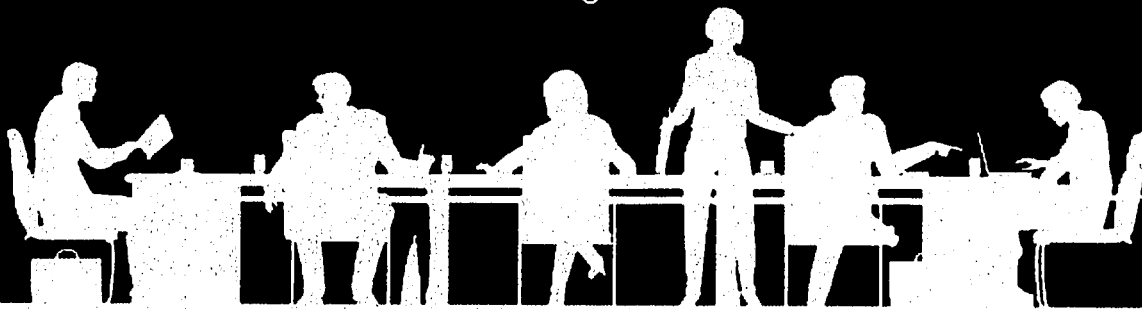

- **Academe and scientific community**



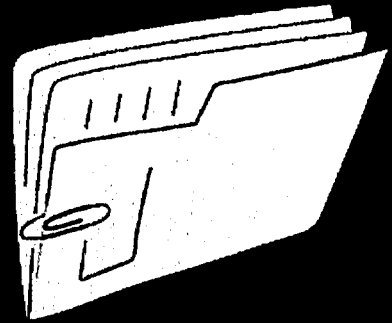
ELIGIBILITY

Nominating Party

A business organization, Research and development institute or institution (RDI), or an academic institution can nominate only one representative during the nomination period. The minimum requirements for a nominating party shall include the following qualifications:

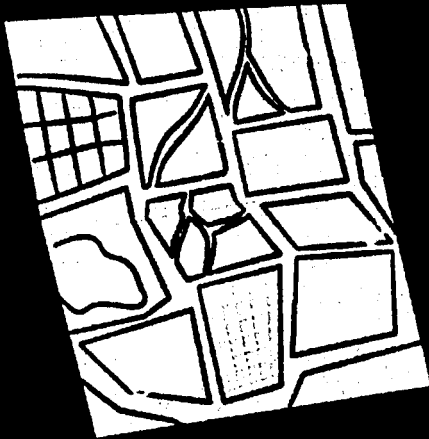
Must be a duly registered or licensed business organization, RDI, or academic institution;

Preferably with nationwide or region-wide coverage of services or operations

If a nominating party is a business organization, it must have notable achievements, honor, or distinction in the fields of science, technology or innovation in the last five years



Individual Nominee

Each nominee may apply and be qualified for only one sectoral representation. The following criteria shall be used in screening the qualifications of the individuals recommended by the nominating parties:

FOR REPRESENTATIVES FROM THE MSMES AND BUSINESS SECTOR

Filipino national of legal age

Director, officer or employee of a business organization,

and has a written certificate from the relevant government agency and must be duly registered to practice in the relevant sector of the Philippine economy.

Engaged in a combination of at least five years ongoing or completed projects,

which are either related to or related to the private sector of the Philippine economy, or projects related to the development of capital goods, or the construction, operation, maintenance, or rehabilitation of infrastructure facilities.

Not holding any elective or appointive position in any government agency

Demonstrates high personal and professional integrity

and has no record of conviction for any crime involving moral turpitude, or any crime involving dishonesty or breach of trust.

Capable and competent to participate in the NIC meetings and activities.

FOR REPRESENTATIVES FROM THE ACADEME AND SCIENTIFIC COMMUNITY

- ✓ Filipino national of legal age

Shall have at least seven years of experience in the field of science and technology, R&D, or innovation from reputable and recognized communities;

- ✓ Engaged in a combination of at least five years ongoing or completed R&D projects or activities related to science, technology, and innovation;

Published scholar or author in science, technology, and innovation

(e.g., public sector innovation, innovation ecosystems, development, knowledge or technology transfer) with at least three published journal articles, locally or internationally, as accepted by the screening committee.

- ✓ **Demonstrates high personal and professional integrity**

and have relevant knowledge, skills, expertise, and ability to make sound judgment; and

- ✓ **Capable and competent to participate in the NIC meetings and activities.**

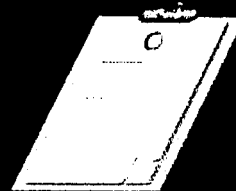

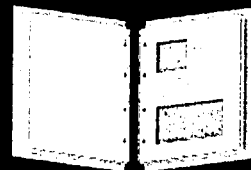
