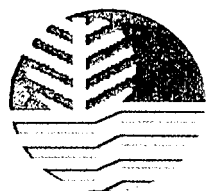


Respectfully submitting herewith is our consolidated report on the above subject.

Please be informed that for the period under report, forty two (42) incidences of apprehension of undocumented forest products, implements and conveyances were recorded with a total volume of 21,225.37 bd.ft. of assorted lumber, 4 units conveyances and 5 units chainsaws were apprehended and still undergoing administrative adjudication proceedings pursuant to DAO 97-32. On illegal mining and illegal wildlife cases, there were no apprehensions reported.

The aforementioned incidences of apprehensions on illegal logging resulted to the filing of criminal case for violation of PD 705 totaling to eleven (11) cases to the Provincial Prosecutors Office within the region.

Attached hereto is the duly accomplished prescribed form of the report.
