2. A two to three-paragraph write up that describes the following:
 - 2.1 First paragraph introduces the woman (full formal name, current designation/position in the office/organization)
 - 2.2 Second and third paragraphs cite the commendable initiatives in climate and disaster resiliency, particularly in the Environment and Natural Resources sector, and/or responses for Covid-19 pandemic

The woman/women organizations to be recommended may come from the government or private sector, civil society, academe or communities. Stories will be screened and those short-listed will be featured in a photo exhibit at the DENR Central Office lobby during the observance of March as Philippine Women's Month.
