POLICY GUIDELINES ON THE ADOPTION OF STANDARD

ESTIMATED USEFUL LIFE OF SEMI-EXPENDABLE PROPERTY

This refers to COA Circular No. 2022-004 dated May 31, 2022 entitled "Guidelines on the Implementation of Section 23 of the General Provisions of Republic Act (RA) No. 11639 also known as the General Appropriations Act (GAA) for Fiscal Year (FY) 2022 relative to the increase in the increase in the capitalization threshold from P15,000.000 to P50,000.00".

Section 4.12 of COA Circular No. 2022-004 stated the following:

1. The agency shall determine/provide the estimated useful life of each semi-expendable property, subject to post audit of COA auditors concerned;

2. The agency shall issue an updated policy/memorandum determining/providing the estimated useful life, as necessary.

Section 4.13 provides that the range of estimated useful life per class is provided as follows:

1. Semi-Expendable Machinery and Equipment

5 to 15 years

2. Semi-Expendable Furniture, Fixtures and Books

2 to 15 years.

The agency shall prepare the specific estimated life for each semi-expendable property based on its experience for each semi-expendable property based on the life of its asset, copy furnished the COA auditors.

In compliance with the abovecited provisions and the DENR's experience on the life of its assets, Semi-Expendable Property of the DENR are hereby classified as follows:

Low-valued items

Php5,000.00 and below

High-valued items

Above Php5,000.00 but below Php 50,0000.00

The Estimated Useful Life of Semi-Expendable Property of DENR is contained in the table attached as Annex "A".
