In preparation for the first round of Indo-Pacific Economic Framework for Prosperity (IPEF) Negotiations in **Brisbane, Australia on 09-16 December 2022**, IPEF Pillars lead agencies have been conducting series of inter-agency meetings in order to identify the best approach to IPEF during the upcoming negotiation and push the offensive and defensive interests of the Philippines.

Hereunder are the salient features and updates relative to inter-agency meetings conducted in relation to the upcoming 1st Negotiating Meeting in Brisbane, Australia:

**A. Online Focus Group Discussion (FGD) for Indo-Pacific Economic Framework for Prosperity (IPEF) Pillar 1 (Trade) - Environment held on 22 November 2022**

- Ma. Regina C. Serafico, the OIC of the Bilateral Relations Division of the BTR moderated the FGD. The Bilateral Relations Division is in charge of the participation of the country to the Indo-Pacific Economic Framework for Prosperity. Ms. Serafico highlighted some environmental objectives for environment chapter themes discussed during the conceptual discussion led by the US, to wit:
  - Ensure that trade and environmental policies are mutually supportive;
  - Protect and preserve the environment (ensuring provisions do not weaken or reduce protections afforded in domestic environmental laws);
  - Promote effective enforcement of environmental laws;
  - Provide opportunities for public participation and information-sharing in environmental policies and law enforcement;
  - Promote sustainable management of fisheries and forests;
  - Promote conservation of marine species;
  - Address Illegal, Unreported, and Unregulated Fishing (IUU) fishing; and
  - Combat illegal trade of wild flora and fauna
- The Environment Module is under Pillar 1 (Trade). The DTI sought the Department's insights on the constraints and specific concerns based on the United States-Mexico-Canada Agreement reference article on Environment;
- It was noted that the key areas should include capacity building on adaptive capacity on the impacts of climate change and mitigation measures;

- DTI flagged the IPEF should be inclusive and should bring a new package of assistance to environment-related activities in the country;
- There will be dedicated access for the Undersecretary for Policy, Planning and International Affairs and official IPEF focal points to the IPEF website;
- Mr. Albert Magalang of CCS-DENR highlighted the participation of the Philippines in an internationally legally binding agreement on plastic pollution; and
- On trans-border researches, the DENR can always propose during the negotiation on the conduct of joint researches, e.g. Invasive Alien Species, carbon sequestration, etc.

**B. During the Inter-agency meeting for IPEF Pillar 2 (Supply Chains) held on 29 November 2022 which was chaired by the Board of Investments (BOI), the following comments/agreements were raised:**

- There are many overlaps in IPEF pillars. The strategy is to construct a holistic framework to attract business partners. The IPEF can be a mechanism that will allow trade and investment in the legislation in US where the Philippines is restricted;
- There should be assurance of environmental safeguards including Circular Economy as the new law on Extended Producer Responsibility aims to ensure efficiency in supply chains that would not cause extreme environmental disruptions;
- IPEF is a framework and not a Free Trade Agreement, but eventually this might work towards having market access;
- The Philippines is participating in all Pillars but some IPEF partners are participating in some pillars. The approach to IPEF is to be offensive and to push more in order get the interests of the Philippines. The challenge would be to identify how and when to declare a product is a critical good. What is a critical product for the Philippine may not be a critical product to other IPEF members. In addition, what is critical to ASEAN may not affect other regions;
- Agencies were reminded of the deadline of submission of comments to the IPEF Pillar 2 non-papers of IPEF partners on 05 December 2022; and
- For the members of the Philippine delegation, agencies were reminded on the processing of Travel Authorities and application of Australian visa.

**C. During the Virtual Philippine delegation meeting/inter-agency meeting for IPEF held on 02 December 2022 which was chaired by DTI Assistant Secretary Allan B. Gepty (with Co-chair DFA Assistant Secretary Eric Tamayo), the following updates and reminders were raised for the members of Philippine Delegation to the IPEF Negotiation on Brisbane, Australia:**

- Asec Gepty reminded that agencies should be prepared regarding certain texts and language to be used;
- On the matter of Environment, Asec Gepty requested the Department to advise the DTI on the extent of sensitivities relative to climate change and environment protection. Some guide questions: *What are the hard commitments on environment treaties? Are there certain reservations when it comes to environment?*
- Asec Eric Tamayo advised the agencies to be familiar with the US Global Cross Border Privacy Rules Declaration (<https://www.commerce.gov/global-cross-border-privacy-rules-declaration>);
- The Environment module is one of the elements without submitted text (only Agenda). Thus, during the negotiation meeting in Brisbane, Australia, it is expected that module would be more of identifying sensitivities, scanning and mapping the situation/environment, and exchanges of views;
- Usec Ceferino Rodolfo who serves as the IPEF Chief negotiator clarified that the Philippines' focus is to bring in investment by using IPEF as platform. He added, we should address some issues that make it difficult for the Philippines to get investments. It is important to talk with other IPEF partners regarding issues as we are trying to capture the benefit in parallel to the texts;

- On Administrative and Logistic matters, ASEC Tamayo of DFA said their Office of Consular Affairs (OCA) is ready to provide endorsement instead of note verbale for those using the regular passports; and
- The DTI reminded that delegates will be responsible for in-land transportation in Brisbane including transfers to and from the Airport
