TO ENJOIN GOVERNMENT AGENCIES TO PROVIDE  
ASSISTANCE FOR THE CONDUCT OF 2022 CENSUS OF  
AGRICULTURE AND FISHERIES**

This refers to the attached memorandum of the Undersecretary and Chief of Staff referring to the letter of the Undersecretary Dennis S. Mapa of the Philippine Statistics Authority (PSA) urging government agencies to provide assistance for the conduct of the 2022 Census of Agriculture and Fisheries (CAF) in 2023.

The CAF is a nationwide undertaking that aims to collect and compile basic information related to agriculture and fishery sectors. In line with the CAF preparations, the PSA would like to seek logistical support and assistance from the department, particularly on the following matters:

National Mapping and Resource Information Authority	Provide the latest land cover and shapefiles to be used as a reference for census workload, training, enumeration, and data validation.
Regional Offices, Bureaus, and Attached Agencies	Provide support to the conduct of census operations by means of giving assistance to any of the following, if possible: a. Transportation b. Accommodation/Training Venue c. Internet connection and equipment ( such as speakers, microphones, projectors, laptops, and desktops)
Land Management Bureau	Provide cadastral maps and maps of areas with boundary conflicts
Strategic Communication Initiatives Service	Post/share the 2022 CAF information and publicity materials online through its official websites and social media accounts and printing/posting of streamers, among others.
