This refers to your FY 2023 targets on the formulation of the Regional Medium-Term ENR Plan for 2023-2028.

Please be informed that PPS with support from the United Nations Development Programme (UNDP) is working on the updating of the ENR Framework Plan 2021-2040 and the update of the guidelines in the formulation of the Regional Medium-Term ENR Plan. This effort aims to translate the administration's ENR strategic thrusts and priorities to actionable strategies and measurable targets at the sectoral and regional levels.

In view of the foregoing, you are hereby requested to revise your target on the formulation of the Regional Medium-Term ENR Plan to the Assessment of the implementation of P/A/Ps indicated in the Regional Medium-Term ENR Plan 2020-2022. The result of the assessment shall serve as input to the ongoing updating of the ENR Framework and Plan. Below is the suggested revision.

The assessment shall encompass the following:

1. Status/Updates on the implementation of PAPs indicated in the 2020-2022 RMTENRP;

2. Achievement of outputs and goals indicated in the logical framework and results matrices, if indicated in the RMTENRP 2020-2022;
3. Updated situational analysis supported with geospatial maps, including universe and baseline for all PAPs per sector. Please encode the universe-baseline data in the attached template;
4. Highlights of environmental and social impacts of the ongoing PAPs;
5. Overlapping functions and PAPs (within and outside DENR);
6. Mapping of investment on PAPs (highlight the total investment received per watershed or PA, encompassing all sectors);
7. Recommendations (include recommendations/proposals for new activities, innovations, and/or delisting current PAPs, with corresponding explanations).

Related to this, you are hereby requested to submit the revised WFP to PPS via email at ppso.ppd@denr.gov.ph not later than 16 November 2023 incorporating the above-mentioned suggested revision. The deadline of submission of assessment report shall not be later than 27 December 2023. Regions with no target on the formulation of RMTENRP for FY 2023 are requested to submit available assessment report on their PAPs.
