In compliance with Administrative Order No. 25 S. 2011 creating an Inter-Agency Task Force on the harmonization of National Government Performance Monitoring, Information and Reporting Systems, Memorandum Circular No. 2023-1 on the Guidelines on the grant of Performance-Based Bonus (PBB) for Fiscal Year 2023 under Executive Order (EO) No. 80, S. 2012 and EO No. 201, S. 2016, agencies are requested to comply with the cited requirements.

As part of our compliance to the NCP-PBB requirements, Special Order No. 2023-697 entitled "Creation of the DENR National Competition Policy Steering Committee (NCP-SC) and Focal Committee (NCP-FC)" was issued. Additionally, the second requirement states that at least 50% of the NCP-Focal Committee Members shall complete the PCC course entitled "Leveling the Playing Field through the National Competition Policy: A Blended Learning Course for Government Agencies" with modules namely:

- Legal Framework for Competition;
- Pro-Competitive Policies and Government Interventions;
- Ensuring Competitive Balance; and
- Enforcement of Competition-Related Laws and Issuances.

In view of the above, we would like to request all DENR NCP-FC members to complete the PCC course modules from the iCLP online hub (https://iclp.phcc.gov.ph/) on or before **24 November 2023.** The knowledge gained from the completion of this training will be used for the conduct of Competition Impact Assessment (CIA) of a specific policy. The module completion and CIA of a policy have to be completed on or before 30 November 2023 to complete the NCP-PBB requirement.

C. NCP - Secretariat

Policy and Planning Service - Policy Studies Division

The NCP Committee shall have the following responsibilities and functions:

A. NCP - Steering Committee

- Advise the NCP-FC with regard to the direction in the overall implementation of its activities; and
- Ensure the submission of the DENR's compliance to the NCP-PBB requirements.

B. NCP - Focal Committee

- Act as the liaison and coordination unit of the agency for NCP concerns;
- Facilitate the DENR's compliance with NCP requirements;
- Coordinate with appropriate offices/units within the covered agency to ensure compliance with NCP requirements namely the list of the DENR's policies, issuances, rules and/or regulation following the prescribed format and the review of at least (1) policy, issuance, rule, and/or

regulation based on the application of the Competition Impact Assessment (CIA) checklist;

- Ensure the timely submission of NCP requirements on or before 30 November 2023 or future prescribed date to the validating agency;
- The NFP-FC members shall complete the Online Learning Hub on Competition Law and Policy entitled "Leveling the Playing Field through the National Competition Policy: A Blended Learning Course for Government Agencies" or other related training requirements; and
- Perform any other functions that may be deemed necessary by the Head of the Agency.

C. NCP - Secretariat

- Provide administrative support to the NCP Steering and Focal Committee; and
- Perform other functions as may be required by the Steering Committee.

This order shall take effect immediately.
