MECHANICS OF THE GAME

General Rules:

1. The contest shall include Division Chiefs, rank-and-file employees, and Contract of Service;
2. Each team shall be composed of utmost five (5) members. The team captain for each team should hold a Division Chief position;
3. The topics of the family feud are ENR related matters;
4. The decision of the judges is final and irrevocable; and
5. Expenses to be incurred shall be charged against DENR funds.

Elimination Round

Quiz Bee:

1. Each team shall select at least two (2) representatives for the quiz bee which shall be done via Zoom on 18 December 2023;
2. There will be a total of fifteen (15) questions composed of Easy (5), Average (5), and Difficult questions (5); and
3. The top five (5) winners shall then proceed to the Family Feud on 19 December 2023.

Family Feud:

1. The game will be composed of three (3) rounds with five (5) questions each, and a money round.
2. One member from the other team faces the other in a face-off as the game master reads the question off the game board;
3. The team that buzzed first in with the correct answer receives control of the board and has the option of playing or passing control to the other team;
4. The team that has the control tries to reveal all of the correct answers to the question before receiving three strikes;
5. If the team receives three strikes without clearing the board, control is passed to the other team;
6. The team that now has the control is able to give one answer in the hopes that it is found on the board.
 - If it is, points are added to the team's score.
 - If not, the other team gets the points.
7. Points are collected as each team finds its answers to the question on the board;
8. Continue the game repeating steps 1 through 6;
9. Each team tries to collect the most points. The team with the most points wins the game for each round.
10. The winner for the third round shall advance to the money round and have a chance to win additional prize.


Money Round:

11. The winning team shall choose one (1) representative to play for the money round.
12. There will be five (5) short questions with very short and definitive answers worth 25 points (*equivalent to ₱2,000*) each. The player has one (1) minute to answer the question.
