- National Mapping and Resource Information Authority.


The venue for these activities shall be in Region IV-A (CALABARZON), since the DENR Central Office Compound lacks the facility needed to accommodate the number of participants for the planned activities.

The Assistant Secretary for Legal Affairs is authorized to adjust the date and venue of the activities in case of conflict with other DENR activities or in exigency of the service.

All training and related expenses to be incurred in the conduct of the committee conference shall be chargeable against the DENR Central Office Funds, costs of travel of the participants shall be chargeable against their Office funds, subject to the applicable accounting and auditing rules and regulations.

A report shall be submitted online through (<https://sites.google.com/denr.gov.ph/Indportal>) to the undersigned through the Human Resource Development Service (HRDS) - Training and Development Division, within fifteen (15) days after the completion of the activity.

This Order shall take effect on the dates specified herein, unless it is in conflict with other DENR activities or in the exigency of the service.
