

**SUBJECT : AUTHORIZING THE CONDUCT OF A LEARNING
EVENT ON THE EMERGING ROLES OF DENR
EXECUTIVES TOWARD AN AGILE ORGANIZATION**

In the interest of the service, and in view of the continuing organizational development in the Department, the conduct of a blended Learning Event on the Emerging Role of DENR Executives in Organizational Transformation is hereby authorized on 23 February 2023, 9:00 AM onwards, in the DENR Social Hall, 2nd Floor, DENR Building, Visayas Avenue, Diliman, Quezon City.

The Assistant Secretary for Human Resources, Strategic Communication, and Sectoral Initiatives is authorized to amend and/or re-schedule the activity in case of conflict with other programs of the Department.

A report shall be submitted to the undersigned within fifteen (15) days upon completion of the activity.

All expenses to be incurred in the conduct of the abovementioned activity and other allowable incidental expenses shall be charged against DENR funds, subject to the usual accounting and auditing rules and regulations.

This Order takes effect on the date specified unless otherwise reset to another date.
