In this regard, we are respectfully inviting you or your authorized representative/s to personally attend our meeting as resource person/s for the said bill. We would also like to follow up on our request for a position paper on the said bill on a letter dated January 28, 2023.

In view of the implementation of the Online Visitors Pass Registration System of the House of Representatives, we are requesting the resource persons and guests who will physically attend the meeting to fill out the Visitors Pass Form on or before March 13, 2023 (Monday). The visitor profiles shall be used by our Visitor Manager for the issuance of Visitor Pass Scan Code. The names of the resource persons/attendees will also be submitted to the Office of the Secretary General for the approval of free antigen testing located in the North Wing, South Wing and South Wing Annex Lobbies prior to their entry to the meeting room. Registered guests will receive their respective scan codes sent through their email which will serve as their Visitor's Pass on the day of visit. Finally, guests who shall personally attend the meeting may either (1) present a negative antigen test result taken within the last 24 hours by a DOH-accredited laboratory using an FDA-certified antigen testing kits; (2) bring their own FDA-certified antigen test kit or purchase antigen test kits at the lobbies and have the antigen test facilitated by our antigen test team on duty, or (3) avail of the on-site free antigen test.

WHEREAS, the United Nations Sustainable Development Goals Action Awards is an annual signature campaign identifying and celebrating changemakers across the world, rethinking ways to drive progress towards the 2030 SGD Agenda;

WHEREAS, The Masungi Georeserve Project was awarded with the Inspire Award in the 2022 UN SDG Action Awards held on September 27, 2022 in Bonn, Germany, besting over 3,000 entries worldwide;
