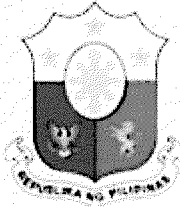

Attached is Note Verbale No. N-001/2023 dated 20 January 2023 from the Executive Secretariat of the Group of 77 concerning the **submission of project proposals for 2023 under the Perez-Guerrero Trust Fund (PGTF) for South-South Cooperation (SSC)**. The Philippines is a contributor to and recipient of funding from the PGTF as part of the country's support and commitment to South-South Cooperation (SSC).

The **sectoral priorities** outlined in the Guidelines and Procedures for applications for funding from PGTF include **Trade, Technology, Food and Agriculture, Energy, Raw Materials, Finance, Industrialization and Technical Cooperation among Developing Countries**. The PGTF can therefore be leveraged as a platform to support the achievement of the Philippines' nationally-determined priorities.

The deadline for the submission of proposals is on 30 April 2023. The maximum amount of funding support for each proposal is pegged at USD 35,000.00. The guidelines for the submission of proposals are found in <http://www.g77.org/pgtf>, which includes the following:

1. The objective is to support cooperation projects involving three or more developing countries. Developmental projects involving a single country are not eligible;
2. A proposal may be submitted by only one country provided that written endorsements from the participating countries are included in the supporting documentation;
3. Any institution of a developing country, governmental or non-governmental, national or local, may submit proposals to PGTF, provided that the proposals are submitted through the national focal point for South-South cooperation or the competent national authority, as appropriate; and
4. Inputs from sources other than PGTF should at least be equal to funds requested from PGTF, and proposals should indicate the exact amount of other sources' funds, source and nature.

UNIO highly encourages your agency to maximize this opportunity by submitting project proposal no later than **30 April 2023**.

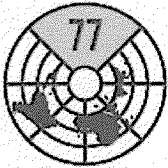

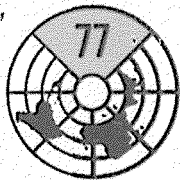

- Any institution of a developing country, governmental or non-governmental, national or local, may submit proposals to PGTF, provided that the proposals are submitted through the national focal point for South-South cooperation or a competent national authority, as appropriate;
- Inputs from sources other than PGTF should at least be equal to funds requested from PGTF and proposals should indicate the exact amount of other sources' funds, source and nature.
