This has reference to the letter from the Office of United Nations and International Organizations–Department of Foreign Affairs (DFA) requesting comments/inputs/amendments on the ESCAP: 79<sup>th</sup> Commission Session: Informal Working Group on Draft Resolutions, particularly on the following resolutions:

- 1. Implementation of the Ministerial Declaration on Protecting our Planet through Regional Cooperation and Solidarity in Asia and the Pacific; and
- 2. Creating regional mechanisms to study, mitigate and minimize disasters in endorheic (inland) water basins and to prevent them, in particular considering modalities for the establishment of the United Nations special programme for the Aral Sea basin.

The seventy-ninth (79th) session of the Economic and Social Commission for Asia and the Pacific (ESCAP) will be held from 15 to 19 May 2023 at the United Nations Conference Centre in Bangkok. Guided by the theme "Accelerating climate action in Asia and the Pacific for sustainable development", the annual session will be an opportunity to strengthen regional cooperation on climate change.

The session will bring together Government leaders from across Asia and the Pacific and other key stakeholders to discuss policy options and areas of regional cooperation required to accelerate climate action in the region and beyond. With dedicated discussions on catalysing climate finance and investments, complemented by a climate solutions fair, the session will allow identifying opportunities, sharing solutions and facilitate engagement of a broad set of partners and stakeholders, to both reduce the risks and impacts of climate change and foster

ambitious climate action in Asia and the Pacific towards net-zero pathways and limit global temperature rise to no more than 1.5 degrees Celsius.

PP3. Acknowledging that the negative humanitarian, environmental and socioeconomic consequences of disasters in endorheic (inland) water basins such as the Aral Sea tragedy go well beyond the region and represent a global concern,

PP4. Taking note of General Assembly resolutions 72/273 of 12 April 2018, 73/297 of 28 May 2019 and 75/266 of 3 March 2021 on cooperation between the United Nations and the International Fund for Saving the Aral Sea, in which the Assembly emphasized the importance of the development and effective implementation of regional environmental protection programmes for sustainable development in Central Asia, including assistance programmes for the countries of the Aral Sea basin, and taking note also of Assembly resolution 75/278 of 18 May 2021 on declaring the Aral Sea region a zone of ecological innovations and technologies,

PP5. Taking note of the findings in the reports of the Economic and Social Commission for Asia and the Pacific entitled "The Aral Sea, Central Asian countries and climate change in the twenty-first century" and "Managing inland water disasters in the Aral Sea: sub-regional pathways for adaptation and resilience", which provide information on

a multisectoral and multidisciplinary disaster risk reduction approach to devising a regional mechanism involving all Aral Sea countries concerned,

PP6. Recalling with appreciation the joint communiqué adopted by the Heads of State of Kazakhstan, Tajikistan, Turkmenistan and Uzbekistan during a meeting of the Council of Heads of the Founding States of the International Fund for Saving the Aral Sea, held in the Avaza national tourist area in Turkmenbashi, Turkmenistan, on 24 August 2018,<sup>4</sup> and the creation of the multi-partner human security trust fund for the Aral Sea region under the auspices of the United Nations,

PP7. Welcoming the outcomes of the multilateral consultations on the development of the United Nations special programme for the Aral Sea basin<sup>5</sup> held in Ashgabat on 18 December 2019 with the Executive Committee of the International Fund for Saving the Aral Sea, Member States and relevant United Nations agencies,

OP1. *Invites* members and associate members of the Economic and Social Commission for Asia and the Pacific, donor countries, multilateral financial institutions, relevant agencies and organizations of the United Nations system and other intergovernmental and regional organizations to continue their efforts within their respective mandates
