This refers to the letter of Undersecretary Maria Francesca M. Del Rosario, Functional Group Head of the Information and Communications Technology Group and Chief Information Officer of the Department of Budget and Management (DBM) dated 30 March 2023 regarding the inclusion of Department of Environment and Natural Resources (DENR) in the **full rollout of online releases** of the Forward Obligation Authority (FOA), Multi-Year Contracting Authority (MYCA), Cash Disbursement Ceiling (CDC), and Non-Cash Availment Authority (NCAA) through the DBM-ADRS pursuant to DBM Circular Letter No. 2022-10 dated 16 August 2022.

The DBM-ADRS, a web-based application facilitates the release of approved DBM Action Documents in **digital format** directly to the authorized users of recipient agencies. 
