SUBJECT : **INVITATION AND REQUEST FOR COMMENTS REGARDING WATER SUSTAINABILITY BILLS FROM THE SENATE COMMITTEE ON SUSTAINABLE DEVELOPMENT GOALS, INNOVATION, AND FUTURES THINKING**

The Senate Committee on Sustainable Development Goals, Innovation and Futures Thinking (SDGIFT) chaired by Senator Pia Cayetano will be conducting a hearing on **08 May 2023, (Monday) 1:00 PM at the Senator Tañada Room, 2nd Floor, Senate of the Philippines** to discuss the proposed measures which seek to provide wider access to safe and potable water to every barangay and promote sustainable use of water resources. Specifically, the following will be tackled during the said hearing:

1. Privilege Speech of Sen. Pia Cayetano entitled "World Water Day" delivered on 22 March 2023;
2. Senate Bill No. 16 - AN ACT PROVIDING FRAMEWORK ON WATER SUSTAINABILITY, by Senator Pia S. Cayetano;
3. Senate Bill No. 310 - AN ACT TO PROMOTE RURAL HEALTH BY PROVIDING AN ACCELERATED PROGRAM FOR THE CONSTRUCTION OF A POTABLE WATER SUPPLY SYSTEM IN EVERY BARANGAY IN THE COUNTRY WITHIN THREE YEARS, by Senator Juan Miguel "Migz" F. Zubiri; and
4. Senate Bill No. 1048 - AN ACT ENSURING SAFE DRINKING WATER, AMENDING FOR THE PURPOSE PRESIDENTIAL DECREE NO. 856, OTHERWISE KNOWN AS THE CODE ON SANITATION OF THE PHILIPPINES AND FOR OTHER PURPOSES, by Senator Joel Villanueva

In this regard, may we respectfully request your comments/recommendations on the above-mentioned bills, in preparation for the upcoming public hearing, as requested by the Committee. Further, may we also request a presentation to discuss the plans and priorities of the newly created Water Resource Management Office amid the challenges of water shortage, for the information of the Committee.
