

The Department of Foreign Affairs-Office of European Affairs (DFA-OEA) respectfully informs your agencies that based on the circular note of the Ministry for Foreign Affairs of Iceland, the said country will be officially called "Iceland" and not the Republic of Iceland. This is not a recent change, the correct name has been Iceland since the country became a republic in 1944. This correction has been made in the United Nations database UNTERM:https://unterm.un.org/unterm2/en.

Hence, the Department respectfully requests your agencies to note that the REPUBLIC OF ICELAND has officially changed its name to ICELAND and to use the country's new name in all your communications.


