Guide Interview Questions for the Testimonial Video

- 1. Introduce yourself: who are you, what do you do for a living, and how many years have you been living in the community?
- 2. What are the environmental challenges that you or the community have encountered in the past?
- 3. Can you briefly describe these challenges and its impacts on your community in terms of the environment, health, financial, security, etc?
- 4. What are the environmental programs, projects, actions, and support that the DENR has conducted or provided to the community to fight/resolve/mitigate these environmental challenges?
- 5. How are the DENR programs, projects, actions, and support beneficial to you and the community? What were the positive changes that you experienced?
- 6. How are you impacted by these programs, projects, actions, and support from DENR? Can you explain what these concrete solutions are?
- 7. What is your message to the DENR on its actions to continuously perform its mandate to protect, conserve, and manage the environment and natural resources?
