SUBJECT: DESIGNATION OF UNDERSECRETARY AUGUSTO D. DELA PEÑA AS UNDERSECRETARY FOR ORGANIZATIONAL TRANSFORMATION

In the interest of the service, **Undersecretary Augusto D. Dela Pena** is hereby designated as **Undersecretary for Organizational Transformation**.

As such, he shall perform the functions and responsibilities of said designation, in accordance with applicable laws, rules and regulations.


He is tasked to develop a structured approach for the development of key management systems to accelerate the execution of strategic plans and the attainment of its expected outcomes, highlighting essential focus areas required to maximize organizational effectiveness and efficiency. In addition, all issues and concerns impacting the environment and national security such as, but not limited to, the National Security Council (NSC), National Task Force for the West Philippine Sea (NTF-WPS), National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) and other related peace and development initiatives shall be coursed through his Office.

He shall also perform such other tasks and duties as the Secretary may direct.

He shall sign documents, as follows:
