Resource persons/guests who will physically attend the said meeting are hereby required to submit the names of your confirmed attendees with contact (cellphone) number together with a copy their valid ID, official email, and negative antigen test result taken within 24 hours prior to the date and time of the meeting, to be emailed at cpwhhor@yahoo.com.

Thereafter, an email will be sent to the official email provided by the confirmed attendees where they can access their account at <https://housepass.hrep.online> using the eight (8) character Visitor HREP ID number and the password provided therein.

Once logged in, the system will display the visitor's dashboard and QR Code. The QR code will be scanned in the HREP entry points to determine the identification and access status.

The Visitor must accomplish and submit the Health Declaration Form (HDF) in the House Pass System (<https://housepass.hrep.online>).

With regard to the negative antigen test result, the same shall be administered by a DOH-accredited laboratory, clinic, or government health facility, OR FDA-approved test kits duly certified by a medical doctor taken within 24-hours prior to the date and time of the visit.

(The list of FDA-approved test kits is accessible on the Official HREP website at <https://www.congress.gov.ph/>).

If the Visitor does not have an antigen test result yet, they may bring their FDA-approved test kit OR they can purchase it at HREP for 350 pesos.

Furthermore, visitors who intend to arrive by personal vehicle must register it on the HousePass System for verification of entry at the North Gate Entrance. The visitor may add companions, provided they are also approved visitors.

Please be guided accordingly.
