This refers to the letter from Achilles Gerard C. Bravo, Assistant Secretary of DBM and Chairperson, AO25 Inter-Agency Task Force-Technical Working Group (IATF-TWG) regarding the DENR's eligibility to the grant of the FY 2021 Performance-Based Bonus (PBB).

However, since the agency achieved a performance rating of below 4 in two (2) out of four (4) Dimensions and was found non-compliant in three (3) of the Agency Accountabilities, the unit/s most responsible (including its head) for the non-compliances will be isolated from the grant of FY 2021 PBB per Section 5.0 of MC 2021-1.

The PMT requested the IATF for the re-evaluation of the submission of the Offices found non-compliant with the Agency Accountabilities. The result showed the isolation of more Offices as they also included in their assessment the submission of the PENROs and Staff Bureaus. Below is the summary of compliances:
