Relative to this, please be advised of the following:

- 1. Health and safety measures shall be observed including proper wearing of face masks and disinfection of hands;
- 2. Kidney ultrasound screening can be availed by both male and female, 18 years old and above, while Prostate ultrasound screening can be availed by male employees aged 40 years and older.
- 3. Employees who wish to undergo Kidney Ultrasound are required to drink 24 ounces or 710 ml of water an hour before the procedure and are advised not to empty their bladder before the ultrasound.
- 4. Those who will avail of the prostate ultrasound screening are advised to refrain from voiding prior to the prostate ultrasound screening.
- 5. Free urologic consultation shall be given by a urologist on duty for those who would be found positive for renal (kidney) or prostate disease.

AUTHORIZING THE CONDUCT OF KIDNEY AND PROSTATE ULTRASOUND SCREENING ON JUNE 21, 2023 AT THE DENR CENTRAL OFFICE
