This refers to the letter dated 13 January 2023 of Assistant Secretary Kira Christianne D. Azucena of the Department of Foreign Affairs (DFA), requesting for comments on the Philippines' possible membership and co-chairing of the UN Global Compact Group of Friends.

Background

- The UN Global Compact is the United Nations Secretary-General's strategic policy and advocacy initiative calling for the alignment of business operations and strategies with 10 universal principles in the areas of human rights, labor, environment and anti-corruption. It is meant to strengthen the engagement of the UN with the private sector in support of the UN goals, including the 2030 Agenda and its 17 Sustainable Development Goals (SDGs).
- The DFA recommends the positive consideration of the Philippines' membership in the UN Global Compact Group of Friends because the membership may play a role in forging stronger partnership with the private sector to deliver more benefits to the public in line with the recently-adopted Philippine Development Plan 2023-2028.
- Moreover, the UN Global Compact Group of Friends currently has fifty-five (55) members, a number of which are strong bilateral partners of the Philippines.
- There are 42 companies in the country that adhere to the principles and format part of the UN Global Compact, which can be accessed thru the following link: https://www.unglobalcompact.org/what-is-gc/participants/search%5Bcountries%5D%5B%5D=158

- Further, there is no financial requirement/obligation to join the Group of Friends, which requires only an investment in time and active participation.
- A Filipino national is currently part of the UN Global Compact Team. Mr. Harold Heredia, a former employee of the Philippine Mission in New York, is currently focal Secretariat support for the UN Global Compact Group of Friends. Should the Philippines decide to join, Mr. Heredia would be able to facilitate the arrangement of meetings between NEDA, DENR and DFA and the UN Global local network, to be held in Manila by the first half of the year.

The Philippines has been invited to join and co-chair the UN Global Compact Group of Friends representing the Global South/developing world.

Launched in 1999, the UN Global Compact is the United Nations Secretary-General's strategic policy and advocacy initiative calling for the alignment of business operations and strategies with 10 universal principles in the areas of human rights, labor, environment and anti-corruption. It is meant to strengthen the engagement of the UN with the private sector in support of the UN goals, including the 2030 Agenda and its 17 Sustainable Development Goals (SDGs). Ms. Sandra Ojiambo is the Assistant Secretary-General of the UN Global Compact, having been appointed by UN Secretary General in early 2022.

The Department recommends the positive consideration of the Philippines' membership in the UN Global Compact Group of Friends based on the following:

- The President recognizes the important role of, and actively encourages and engages, the private sector in policy planning, making and implementation of the country's development priorities. In the recently-adopted Philippine Development Plan 2023-2028, the President underscores in his message that "every Filipino has a part to play in our nation's journey to prosperity. The need for united and coordinated efforts of the public and private sectors, as well as civil society, has grown ever more vital as we enter into new years of post-pandemic recovery and as global headwinds threaten to derail our progress as a people." There is a clear directive for a stronger partnership with the private sector to deliver more benefits to the public;
- The UN Global Compact Group of Friends currently has fifty-five (55) members, a number of which are strong bilateral partners of the Philippines;¹

- In the second part of the 15th session of the Conference of Parties to the Convention on Biological Diversity held in Montreal, Canada on 17-19 December 2022, DENR Secretary Maria Antonia Yulo Loyzaga expressed keen interest to meet with the local network of the UN Global Compact in PH, cognizant of their important role, including in mainstreaming resilience throughout the bureaucracy;

UN GLOBAL COMPACT GROUP OF FRIENDS

TERMS OF REFERENCE

BACKGROUND

The Group of Friends of the UN Global Compact is an informal group of Government representatives that meets on a regular basis to discuss the work of Global Compact and opportunities for Governments. These meetings take place in New York, usually on a quarterly basis.

Members of the Group of Friends are encouraged to engage with the UN Global Compact on a programmatic basis, in alignment with their national policy priorities or interests, and to consider membership in the UN Global Compact Government Group.

TERMS OF REFERENCE

1. PARTICIPATION CRITERIA

As an informal group, participation in the Group of Friends is open to representatives from all Member States of the United Nations. Government representatives that seek to join a meeting of the Group of Friends are requested to confirm their attendance with the Government Relations team.

The UN Global Compact places no restriction on the level or seniority of representatives at meetings of the Group of Friends.

Unlike the UN Global Compact Government Group, participation in the Group of Friends is not contingent on material support for the Global Compact, and does not provide a formal channel for Government engagement within the UN Global Compact Board.

All Government Group members are invited to attend the meetings of the Group of Friends, and outcomes from the Group of Friends will also be shared with the Government Group. Conversely, select members of the Group of Friends may be extended an invitation to join the Government Group, based on their commitment to supporting the UN Global Compact's goals and activities.

2. MEETINGS OF THE GROUP OF FRIENDS

Typically, meetings of the Group of Friends are short gatherings that include an update on the Global Compact's activities and management, as well forward-looking information on plans and strategy. Presentations by the UN Global Compact are followed by an interactive session, during which participants are encouraged to express their views and perspectives on the UN Global Compact.

During the meetings of the Group of Friends, the UN Global Compact may share key documents, as well as an agenda. The UN Global Compact also compiles minutes of the meeting, which are then shared with participants.

In principle, meetings of the Group of Friends will be chaired by interested Governments, who partner with the UN Global Compact in hosting the Group, communicating with other missions, and preparing meeting documents. The UN Global Compact encourages Governments from developed and

developing countries to serve as Co-Chairs as a way to promote an inclusive discussion forum.
