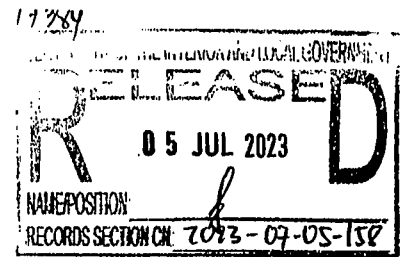
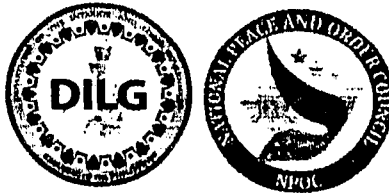

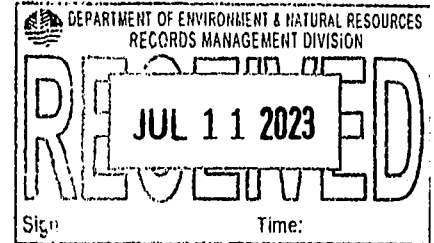

Series of 2023

**A RESOLUTION ENJOINING LOCAL PEACE AND ORDER COUNCILS TO
ALIGN THEIR PLANS AND PROGRAMS WITH CHAPTER 13: "ENSURE PEACE
AND SECURITY AND ENHANCE ADMINISTRATION OF JUSTICE" OF THE
PHILIPPINE DEVELOPMENT PLAN 2023-2028**

WHEREAS, the Marcos Administration envisions a united and collective effort towards sustainable and inclusive growth and a commitment to uplift the lives of the Filipino and ensure a *matatag, maginhawa, at panatag na buhay para sa lahat*.

WHEREAS, the Philippine Development Plan (PDP) 2023-2028 is the flagship medium-term development plan encapsulating the vision of the Marcos Administration, particularly in addressing short-term and medium-term constraints during a period of economic recovery.

WHEREAS, the PDP 2023-2028 is a plan framed by the Marcos Administration's 8-point socioeconomic agenda which seeks to address both short-term issues and medium-term constraints to growth and inclusion.

WHEREAS, the PDP 2023-2028 captures a whole-of-government and whole-of-society approach in establishing an inclusive and coordinated plan to recover from the effects of the pandemic and to drive forward the shared goals and aspirations of every Filipino.

WHEREAS, the manifestation of peace and security is a necessary condition in allowing the implementation of development activities that bring more opportunities for growth and innovation.

WHEREAS, protection from conflict, crimes, and other threats, and the effective and efficient administration of justice is necessary to promote the quality of life and inspire trust and confidence among stakeholders through integrity, accountability, and accessibility.

WHEREAS, the Philippine National Police (PNP) is the government's primary law enforcement agency tasked to uphold peace and order, safeguard the Filipino communities, and enforce the law to eradicate criminality.

WHEREAS, the Armed Forces of the Philippines (AFP) shall organize, train, equip, deploy, and sustain forces in the conduct of operations to protect the sovereignty of the state and integrity of national territory from terrorism, aggression, and subversion.

WHEREAS, the Department of Justice (DOJ) is the primary department tasked to uphold the rule of law and to maintain a just and orderly society through an effective, speedy, and compassionate administration of justice.

WHEREAS, the local peace and order councils are identified to be vital in fostering the various aspects of peace-building in coordination with various national agencies and law enforcement agencies.

WHEREAS, Chapter 13 of the PDP 2023-2028 establishes the overall strategy framework to ensure peace and security and enhance the administration of justice in the country.

WHEREAS, Sub-chapter 13.1 highlights the four (4) outcomes of the strategy framework in ensuring peace and security, namely: *Protection and Development of Conflict-Affected Communities Sustained, Quality of Life of People Safeguarded from Criminality, Protection and Safety from Natural Hazards and Other Security Threats Ensured, and Territorial Integrity and Sovereignty Upheld and Protected.*

WHEREAS, Sub-chapter 13.2 highlights the three (3) outcomes of the strategy framework in enhancing the administration of justice, namely: *Quality and Efficiency in Disposition of Cases improved, Access to Quality Free or Affordable Legal Services by Filipinos Improved, and Quality of Life of Persons Deprived of Liberty (PDL) improved, and Productive Re-Integration of PDL in the Community Ensured;*

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED THAT, the National Peace and Order Council (NPOC), Regional Peace and Order Councils (RPOCs), and all local peace and order councils (POCs) align their plans and programs with Chapter 13 of the PDP 2023-2028 and integrate the Strategy Framework in the policies and activities of all POCs nationwide.

RESOLVED FURTHER THAT, the Philippine National Police (PNP) shall strengthen their efforts towards professionalization, rights-based policing, and improving capability against traditional and non-traditional threats.

RESOLVED FURTHER THAT, the Armed Forces of the Philippines (AFP) shall strengthen their capacity on security assessment, operations, geopolitical response, and ensure the development of a strong and self-reliant defense force.

RESOLVED FURTHER THAT, the Department of Justice (DOJ) shall ensure strong coordination, communication, and collaboration efforts to bolster the effective and efficient administration of justice and accountability.


RESOLVED FURTHERMORE THAT, the Department of the Interior and Local Government (DILG) shall support the development of peace and security through strengthening of the POCs through the POC Performance Audit, and provision of capacity building interventions.

RESOLVED FINALLY THAT, a copy of this resolution be presented to the AFP, PNP, DOJ, OPAPRU, NTF-ELCAC, and other members of the peace and security sector.



NPOC RESOLUTION NO. 3
Series of 2023

**A RESOLUTION ENJOINING THE INSTITUTIONALIZATION OF THE DILG'S
BUHAY INGATAN, DROGA'Y AYAWAN (BIDA) PROGRAM**

WHEREAS, Pursuant to Republic Act No. 6975, also known as the "*Department of the Interior and Local Government Act of 1990*", the DILG is mandated to promote peace and order, ensure public safety, and strengthen local governance aimed towards the effective delivery of basic services to the citizenry. As such, the DILG continues to develop and formulate plans, programs, and policies to reinforce this mandate.

WHEREAS, the DILG issued the guidelines in the implementation of holistic approach of the "*Buhay Ingatan, Droga'y Ayawan (BIDA) Program*" that aims to counter the proliferation of illegal and dangerous drugs with the assistance of DILG Regional Offices and local government units across the country.

WHEREAS, the BIDA Program, in line with the mandate of the Peace and Order Councils and the current administration, seeks to improve the quality of life, and safeguard the Filipino people leading to the attainment of our 2040 ambition to provide "*Matatag, Maginhawa at Panatag na Buhay.*"

WHEREAS, the BIDA Program envisions to create a lasting impact towards the reduction of drug proliferation among communities, encourage people to stay away from drugs, and remove the stigma against drug dependence, and addiction through ensuring access to recovery, and rehabilitation.

WHEREAS, the BIDA Program implements a multisectoral approach which includes meetings, conferences, and activities with other National Government Agencies (NGAs), Local Government Units (LGUs), and Civil Society organizations (CSOs).

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED THAT, the NPOC and RPOCs hereby support the institutionalization of the DILG's *Buhay Ingatan, Droga'y Ayawan (BIDA) Program* to raise awareness, promote health and wellness, strengthen institutions in the implementation of drug supply and demand reduction activities, and encourage multi-sectoral participation.

RESOLVED FURTHER THAT, the RPOCs shall encourage its sub-national POCs in giving priority to preventive or educational programs, and in establishing Community-Based Drug Rehabilitation Programs, by appropriating substantial amounts in their respective Peace and Order and Public Safety (POPS) plans.

RESOLVED FURTHER THAT, the members of the NPOC shall foster meaningful partnerships with stakeholders in the provision of livelihood and job opportunities to support rehabilitated and integrated Person Who Use Drugs (PWUDs), out-of-school youth (OSYs) and their families, and in increasing access to rehabilitation and integration programs, among others.

RESOLVED FURTHER THAT, all members of the NPOC and RPOCs shall advocate drug-free workplaces in their agencies.

RESOLVED FURTHERMORE THAT, all members of the NPOC and the RPOCs shall work closely with the DILG, as lead implementer of the BIDA Program, in providing oversight, support, and technical assistance in the implementation of the program.

RESOLVED FINALLY THAT, a copy of this resolution be provided to all members of the NPOC for reference, guidance, and integration of the BIDA Program to their respective mandates, plans, programs, and activities.
