This has reference to the letter dated 08 September 2023 from the Department of Trade and Industry (DTI), requesting comments and additional inputs on the potential outcome documents for the 13 WTO Ministerial Conference on Dialogue on Plastic Pollution and Environmentally Sustainable Plastic (**Annex A**).

Please be informed that Geneva WTO-PM and the DTI provided their proposed inputs and edits on the Shared Principles and Action as reflected in Annex B. Considering that DPP is expected to play a complementary role and feed into the Intergovernmental Negotiations Committee (INC) to develop an international legally binding instrument on Plastics pollution, as well as with other relevant processes. We viewed that there should be a continued synergy in the Philippine position on the plastic-related initiatives the Philippines is part of.

DIALOGUE ON PLASTIC POLLUTION AND ENVIRONMENTALLY SUSTAINABLE PLASTICS TRADE (DPP)

FIRST DRAFT - POSSIBLE MC13 STATEMENT

The following communication, dated 11 August 2023, is being circulated at the request of the Dialogue Coordinators.

We, the Ministers representing the following Members of the WTO [], issue this statement:

Preamble

(23-0000)

Recalling that the Marrakesh Agreement establishing the WTO recognizes the role of trade in achieving the objective of sustainable development and the need to protect and preserve the environment.

Expressing our deep concern about the triple planetary crisis of biodiversity loss, pollution and climate change and their related natural disasters, and recognizing that these challenges are inextricably interlinked and mutually reinforcing, and that they are driven largely by unsustainable patterns of consumption, production and disposal and their related economic and health costs.

Acknowledging the negative impact that plastic pollution has on the environment, including in the marine environment, on land, in the air, and in water, particularly in small and vulnerable economies and Small Island Developing States (SIDS), as well as on economies, including the blue economy, and on human health, while recognizing the role played by plastics in society.

Recognizing the transboundary nature of plastic pollution, plastic waste and plastics trade, making it crucial for members to cooperate and coordinate their efforts to address this global problem and its adverse and spill over impacts on the environment and human health and acknowledging the growing urgent need to tackle the plastic pollution crisis, the need for coordinated action across policy areas and the need to constantly assess approaches consistent with evolution in science and knowledge.

Calling for an ambitious international legally binding instrument on plastic pollution to protect human health and the environment, pursuant to the UN Environment Assembly resolution 5/14 to end plastic pollution.

Acknowledging the Basel, Rotterdam and Stockholm Conventions and commending the successful adoption of the Plastic Technical Guidelines under the Basel Convention, fostering international cooperation and progress towards environmentally sound and safe plastic waste management.

Highlighting the importance of the rules-based multilateral trading system and of trade-related cooperation as a contribution to global efforts to end plastic pollution, including through the implementation of trade-related plastics measures across the life cycle of plastics, including by preventing the leakage of plastic pollution, sharing of relevant data and information on the plastics economy, and promotion of safe and sustainable solutions, in particular those important for developing members.

Acknowledging the ongoing international, regional and domestic efforts to address plastic pollution and the contribution by many of these processes and relevant stakeholders to the Dialogue.

Reaffirming the Dialogue's Ministerial Statement (WT/MIN(21)/8/Rev.[X]) issued on 10 December 2021 which committed co-sponsors to work towards "concrete, pragmatic, and effective outcomes" on the trade-related aspects of plastics pollution in order to contribute to the global response to end plastic pollution on the areas of substantive focus further articulated by the Dialogue Plan (INF/TE/IDP/W/5): Cross-cutting issues, including capacity building and technical assistance, international cooperation, and transparency and data; Reduction to tackle plastic pollution; and Promotion of trade to tackle plastic pollution.

Highlighting the progress of the collective work of the Dialogue on Plastic Pollution since its launch, including:

- The substantive technical work and discussions of the Dialogue, with the support of the expertise from delegations and relevant stakeholders, that has helped advance our collective knowledge of the intersection between trade, trade policies and plastic pollution, under each of the workstreams of the Dialogue, and supported the production of several outputs from the Dialogue such as those reflected in Annex [X], including information documents, factual summaries and reports, specialized Workshops, surveys and communications.
- The enhanced, close, and constructive cooperation with other international and regional efforts and institutions, such as with the Intergovernmental Negotiating Committee to develop an international legally binding instrument on plastic pollution, including in the marine environment (INC), the United Nations Environment Programme (UNEP), the World Customs Organization (WCO), the United Nations Conference on Trade and Development (UNCTAD), the Basel, Rotterdam and Stockholm (BRS) Conventions, the Food and Agriculture Organization (FAO), the World Health Organization (WHO), the International Organization for Standardization (ISO), the International Bamboo and Rattan Organisation (INBAR), the World Bank Group, the Latin American Integration Association (ALADI), the Organisation for Economic Co-operation and Development (OECD) and a range of stakeholder organisations involved in the work of the Dialogue.

We have accordingly reached the following shared understandings:

We will continue to cooperate on the basis of the following shared principles:

- Focusing on trade-related aspects and actions that participating Members could take collectively and individually to support global efforts to end plastic pollution.
- Deepening cooperation and collaboration with other international organizations, secretariats and processes, ensuring complementarity and avoiding duplication, and ensuring that the work is informed by and supports the ongoing INC negotiations, and implementation of relevant Multilateral Environment Agreements, as well as relevant technical and scientific developments.
- Addressing challenges facing WTO members, in particular developing members, LDCs and SIDS, in the trade related aspects of plastic pollution and sustainable development goals.
- Emphasizing the role of multilateral trade cooperation including in promoting transparency and good practices.
- Continued open, inclusive and transparent engagement with all WTO members and all relevant stakeholders.
- Continuing our efforts in exploring the interlinkages of plastic pollution and trade in other areas.

We agree to the following actions:

- Improve transparency, monitoring and understanding of trade flows across the full life cycle of plastics, including flows of plastics embedded in or associated with internationally traded goods, including through the actions listed in Annex [X].
- Address trade-related capacity building and technical assistance needs of developing members, least developed members and SIDS, such as those listed in Annex [X], including through the implementation of Aid for Trade to address plastic pollution and to launch a mechanism to match funding opportunities with specific needs identified by developing members, particularly LDCs and SIDS, to implement trade-related policies and measures to tackle plastic pollution.
- Promote trade-related cooperation, including through implementing trade-related measures, such as those listed in Annex [X], to reduce unnecessary or harmful plastics and plastic products such as those listed in Annex [X].
- Promote trade-related cooperation, including through implementing trade-related measures such as those listed in Annex [X], to address the environmental, social and health impacts and leakage associated with primary plastics, polymers, additives and plastics products.
- Promote trade, including through implementing trade-related measures such as those
 listed in Annex [X], that contributes to ending plastic pollution and results in safe
 circularity, including trade in environmentally sustainable, safe, and effective non-plastic
 substitutes and environmentally sustainable, safe, and effective plastic alternatives and
 re-use, repair and re-fill systems such as those listed in Annex [X], with a focus on those
 of interest to WTO Members, in particular developing members, including SIDS, and least
 developed members, and opportunities for their MSMEs.
- Promote trade, including through implementing trade-related measures, such as those
 listed in Annex [X], of goods, services and technologies to tackle plastic pollution, including
 those necessary for environmentally sound and safe waste management and clean up,
 using the waste hierarchy, appropriate to local development circumstances and needs,
 and in line with Basel Convention Technical Guidelines on environmentally sound waste
 management.
- Promote trade-related cooperation, including through implementing trade-related measures, such as those listed in Annex [X], to contribute to the control of cross-border movement of plastic pollution, including through, for example, effectively implementing the Basel Convention Plastic Waste Amendments and its Plastic Technical Guidelines relevant to the management of plastic waste, fostering international cooperation and progress towards environmentally sound plastic waste management.

We call attention to the annexes¹ to this statement that reflect our collective and individual efforts so far to identify practices and options to implement trade-related measures and opportunities for cooperation to contribute to ending plastic pollution.

We recognize the need to periodically update the annexes based on global, regional and domestic efforts, as well as on technical and scientific developments, and encourage efforts and commitments by a range of co-sponsors to foster and implement collective and individual actions in this respect.

We will continue to hold dedicated discussions with a view to identify best practices and share experiences regarding all topics identified in the Dialogue. We will work to develop a new Dialogue Plan in the months following MC13. We will look for further concrete, pragmatic, and effective outcomes on these actions and understandings at the latest by MC14.

Reflecting such work, and recognizing the need to periodically update this annex based on global, regional and domestic efforts, as well as on technical and scientific developments, the open, illustrative, non-exhaustive and evolving compilation below has been developed based on the specific TrPMs that have most often been identified in the TrPMs Survey and in dialogue discussions:

Preliminary Comments Dialogue on Plastic Pollution and Environmentally Sustainable Plastics Trade Potential Outcome Document for the 13th WTO Ministerial Conference (MC13)

Shared principles	Geneva WTO-PM deems that Members should recognize the need for systems change to the full life cycle use of plastics, including the importance of trade related actions to support the reduction of virgin plastics production and the promotion of reuse models, recycling and adoption of effective plastic substitutes and alternatives. Given the INC may focus on the definitional aspects of plastic typologies, efforts should be made in the outcome document to avoid discussing technical definitions. The definitions could be left open-ended, with specific examples of illustrative actions being listed in the Annexes, such as national bans on single-use plastics and national legislation or technical requirements related to packaging and recycling targets.
	Geneva WTO-PM recommends the inclusion of a principle to promote the sustainable design of products and materials, which would be consistent with a principle present in the preamble of UNEA Resolution 5/14 of 2022.
	Geneva WTO-PM also suggests including a reference to the "polluter pays principle", which serves as the foundation for the Philippine Extended Produce Responsibility Act (EPRA) of 2022. Geneva WTO-PM proposes a reference to "pursue comprehensive approaches that address the full life cycle of plastics including through the principle of extended producer responsibility." DTI-BITE supports this suggestion aligned with the EPRA. We would suggest the language as: "Pursuing comprehensive approaches that address the full life cycle of plastics including through the principle of extended producer responsibility, among others."
	Geneva WTO-PM proposes including a reference to supporting a people centered approach to the plastics pollution problem, including by supporting increased consumer awareness and improved labeling for recycling.

	DTI-BITR suggests including a principle to support innovation, research and development on the interlinkages of plastics pollution and trade. This aligns with Parties' commitment to deepen cooperation and collaboration with international organizations, as well as in identifying best practices and guidelines, where appropriate.
Actions (Bullet No. 1) - Transparency Improve transparency, monitoring and understanding of trade flows across the full life cycle of plastics, including flows of plastics embedded in or associated with internationally traded goods, including through the actions listed in Annex [X].	Geneva WTO-PM supports a language that encourages the updating of the World Customs Organization (WCO) Harmonized Commodity Description and Coding System (HS System) to better track the flow of embedded plastics in goods as well as to improve the classification of plastics substitutes and alternatives, including through the differentiation of materials that are non-agricultural in application (Note: UNCTAD has noted that some plant-based substitute materials continue to be subject to SPS regulations even though they are used purely in packaging or textiles).
	DTI-BITR supports the Geneva WTO-PM's suggestion. However, we note that the WCO work may be reflected in Annex I together with the extensive list of actions to be carried out in the Dialogue. The Annex is still for finalization.
Actions (Bullet No. 2) - Technical assistance and capacity building – needs identified Address trade-related capacity building and technical assistance needs of developing members, least developed members and SIDS, such as those listed in Annex [X], including through the implementation of Aid for Trade to address plastic pollution and to launch a mechanism to match funding opportunities with specific needs identified by developing members, particularly LDCs and SIDS, to implement trade-related policies and measures to tackle plastic pollution.	DTI-BITR supports the inclusion of launching a funding mechanism as it signals a tangible outcome for technical assistance and capacity building, particularly for developing WTO Members, LDCs and SIDS. We suggest including a reference to the cooperation with partner international organizations in carrying out technical assistance related to plastic pollution.

Actions (Bullet No. 6) - Promotion – Goods, services and technologies for environmentally sound waste management

Promote trade, including through implementing traderelated measures, such as those listed in Annex [X], of goods, services and technologies to tackle plastic pollution, including those necessary for environmentally sound and safe waste management and clean up, using the waste hierarchy, appropriate to local development circumstances and needs, and in line with Basel Convention Technical Guidelines on environmentally sound waste management.

Geneva WTO-PM seeks further information from relevant agencies on what trade and investment-related measures would facilitate increased investments for waste management and materials recovery facilities. Geneva WTO-PM noted that investments for municipal waste management would require build-operate-transfer modalities and are devolved to local government units (LGUs).

Actions (Bullet No. 7) - Promotion - Practices

Promote trade-related cooperation, including through implementing trade-related measures, such as those listed in Annex [X], to contribute to the control of cross-border

Geneva WTO-PM supports language that strengthens this bullet on the crossborder control of plastic waste, particularly in relation to the Basel Convention Plastic Waste Amendments. Geneva WTO-PM notes that a substantial level in the trade of plastic waste is not covered under the Basel Convention's Prior movement of plastic pollution, including through, for example, effectively implementing the Basel Convention Plastic Waste Amendments and its Plastic Technical Guidelines relevant to the management of plastic waste, fostering international cooperation and progress towards environmentally sound plastic waste management.

Informed Consent (PIC) procedure and a significant proportion of this trade continues to be prone to circumvention or mislabeling from exporters. Given the asymmetries in capacities among customs administrations, it would be important for the country of origin to assume greater responsibility over risk management in assessing plastic waste-related consignments leaving their jurisdictions.

This refers to the report from the Philippine Mission to the WTO in Geneva regarding the first draft of the coordinators' shared vision and elements of a potential outcome document for the 13th WTO Ministerial Conference (MC13) on Dialogue on Plastic Pollution and Environmentally Sustainable Plastics Trade (ZWTO-264-2023 dated 23 August 2023).

Among others, the draft document (see Annex A) highlights the following points:

- Importance of trade-related cooperation as a collective effort toward ending plastic pollution:
- The results of the Dialogue's Aid for Trade needs assessment survey, and the survey of trade-related measures by Members;
- Addressing the challenges faced by developing countries, particularly Least Developed Countries (LDCs) and Small Island Developing States (SIDS);
- Provision of technical assistance and capacity-building activities for developing countries to address challenges related to plastic pollution; and
- Promotion of trade that contributes to ending plastic pollution, including the use of sustainable and effective non-plastic substitutes and the promotion of opportunities for MSMEs.

In line with this, we would like to request the DENR's comments, additional inputs and guidance on the proposed elements of the draft outcome documents to reflect the Philippine priorities and efforts in ending plastic pollution. The Mission and the BITR provided preliminary comments on the draft (see Annex B).

The UNCTAD's report on "Plastic Pollution: The Pressing Case for Natural and Environmentally Friendly Substitutes to Plastics" and UNEP's policy paper on "Turning off the Tap: How the World Can End Plastics Pollution and Create a Circular Economy" are also attached to the Geneva WTO-PM report, for additional reference.
