This is in reference to the letter from the Office of the Presidential Adviser on Peace, Reconciliation, and Unity (OPAPRU) dated 18 September 2023, regarding the aforementioned subject.

In preparation for the upcoming 2nd ICCMN Socio-Economic Subcluster Coordination Meeting, an internal meeting was convened on September 21, 2023 to discuss the necessary actions to be taken to ensure a productive and effective discussion during the upcoming coordination meeting. The key agreements during the preparatory meeting are as follows:

- a. NAMRIA to determine the Land Classification of the two priority MILF Camps located in Barangay Tugaig, Barira, Maguindanao del Norte and Barangay Tampara, Munai, Lanao del Norte. NAMRIA to make a brief presentation during the meeting.

- b. NAMRIA to provide a copy of the generated maps to LMB and FMB to provide recommendations on which appropriate land acquisition or tenorial instrument shall be used.
- c. PPS to identify and present the available forest guards for hiring in areas identified by the OPAPRU.
- d. The Office of the Director for BARMM Affairs to lead the coordination with OPAPRU, monitoring of activities, and development of a strategic roadmap under this initiative in coordination with PPS.
- e. PPS to present the overview of Project Transform and consider its intervention for further development of holistic socio-economic interventions in the two priority MILF camps with high potential for development.

With this, we would like to invite your designated representative to the 2nd ICCMN Socio-Economic Subcluster Coordination Meeting. This meeting will be attended by the OPAPRU, Department of Agrarian Reform (DAR), Ministry of Environment and Natural Resources (MENRE), and Ministry of Agriculture, Fisheries, and Agrarian Reform (MAFAR), and will be held on **29 September 2023 at the Philippine International Convention Center (PICC), Pasay City from 9:00 AM to 11:30 AM**. 
