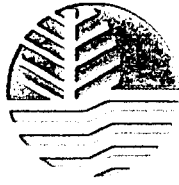

In line with the “*Guideline on the Regional ENR Statistical Profile*” issued by Undersecretary Analiza Rebuella - Teh on August **04 August 2023**, please be guided by the following:

1. Deadline for posting of the Regional ENR Statistical Profile in the respective regional websites: 30 September 2023

2. Means of Verification

- *Means of Verification:* Email message sent by the Regional Office to SDRMD at sdrmd@denr.gov.ph containing a screenshot of the ENR Statistical Profile posted on the regional website and the hyperlink of the page.

3. User Access

To prevent unauthorized changes in the statistical tables posted in the website, ensure that the access to the statistical tables is set to VIEWER only.

4. Clarification on some statistical tables

Forestry Sector

- *Table 6-21 related to Existing Tenurial Instruments* - Data to be provided should have the status of existing or not yet expired.
- *Table 22 Registered Lumbers* - Delete/Remove the column “Lumber Production”.

Water Sector

- *Table 2 Summary of Water Permittees by Water Sources* - The unit of measurement should be in lps not in mcm.
- There are a total of 16 tables in the water sector which include data related to the water permittees, river basin, Manila Bay and Laguna Lake. Only post the statistical tables that are applicable to your respective regions..

Mines Sector

- Mines related data will be provided by the MGB Regional Office to the DENR Regional Office by 26 September 2023.

Environment Sector

- Environment related data will be provided by the EMB Central Office to the SDRMD by 26 September 2023. This will subsequently be distributed to the regional offices for inclusion in the ENR Statistical Profile.

Other Information

- For data that are not yet validated and verified, kindly write at the bottom of the table **“Note: Preliminary data, subject for validation.”**
