
UP-CIFAL Philippines is one of the 26 global CIFAL centers affiliated with United Nations Institute for Training and Research (UNITAR) that promotes the Sustainable Development Goals (SDGs) through capacity building and research. UP-CIFAL Philippines, in partnership with USAID Safe Water and the Water Alliance, will conduct the abovementioned course in nine (9) weeks with breaks in between. The course is intended for professionals from national and local government, water service providers, and private sector who are interested in a pragmatic and holistic framework that addresses issues on water sustainability and its relation to integrated water resource use.

Relative to this, may we invite interested **middle-to-senior level personnel (preferably SG-18 and above)** to participate in the said course. The course fee is **Php 10,000.00 per learner**. A joint certificate from UNITAR and UP-CIFAL Philippines will be awarded to learners upon completing the course.

Pursuant to the Manual of Authorities (DAO No. 2022-09), interested personnel (*i.e., below DCs personnel from Central Office and all DCs and above from Central Office, Regional Offices, Bureaus*) shall submit the accomplished Endorsement Form (see attached) to the Training and Development Division-HRDS **on or before 03 February 2023** for the preparation of Special Order. Extended deadline of submission of nominations to UP-CIFAL is on 07 February 2023.
