This refers to the Climate Change-related activities with the corresponding budget on 003—Climate-Change-Related Activities, Risk Resiliency Program (RRP).

The Risk Resiliency Program (RRP) is the Government's convergence budgeting program under the Cabinet Cluster on Climate Change Adaptation and Mitigation – Disaster Risk Reduction (CCAM-DRR). The RRP is aimed at strengthening and scaling up province-based planning and budgeting of climate-resilient investments at the sub-national and national levels.

With the recent adoption of the National Adaptation Plan (NAP) for 2023 to 2050, the RRP, which initially targeted 24 climate-vulnerable provinces and 4 major urban centers, has broadened its scope to address areas exposed to various climate impact drivers identified in the NAP.

Based on the attached list of priority areas (Annex A), each Regional Office has three or more vulnerable provinces or provinces exposed to climatic impact drivers (CIDs) as identified in the NAP. In line with this, below are the proposed list of climate change-related activities under the said budget item which the regional offices can implement to help support the implementation of the said program:
