NATIONAL POWER CORPORATION

- Created under Commonwealth Act No. 120 on 03 Nov 1936
- NPC Charter established through Republic Act 2641 in 1960
- NPC Charter revised through RA 6395 in 1971, which states that NPC shall be non-profit to perform power generation and transmission function
- Restructured through RA 9136 or EPIRA in June 2001

Retained as a GOCC (non-profit)

- Performs missionary electrification functions, providing power generation and associated power delivery systems in areas not connected to the transmission system.
- Manages watersheds.
- Operates/maintains dams used for power generation.
- Operates/maintains generation assets transferred to PSALM pending their disposal.



Annual Development Fee for land use within protected area

Request:

Allow NPC to pay one-time Development Fee for its projects

and the first than the second of the first than the second of the second

Justifications:

- DAO 2019-05, Rule 25.3, non-profit gov't projects are allowed payment of one-time Development Fee
- NPC is non-profit per RA 6395 with projects subsidized by UCME
- Per RA 9136 IRR Sec 2, missionary electrification function shall be funded from from sales and Universal Charge from electricity end-users



Pending PAMB Clearance for San Pascual DPP (SPDPP) in Masbate, located w/in 40-m legal easement awaiting legal decision of DENR R5

Request:

- Resolution of easement issue & issuance of PAMB Clearance
- Possible provision of timeline for issuance of PAMB Clearance

Justification:

- PAMB Clearance application filed as early as 20 Oct 23 and approved by En Banc on 23 Nov 23
- For ECC Amendment application of Fuel Oil Storage Tank Project
- Titled/LGU-donated A&D land where SPDPP was constructed in 2010 outside 20-m legal easement for coastal areas
- Ticao-Burias Pass Protected Seascapes declared in 2019 expanded the legal easement from 20-m to 40-m, and overlapped the SPDPP area

Pending Guin-awayan DPP SAPA application at CENRO-Mobo, Masbate

Request:

Provisional authority to utilize the area

 Policy/directive on land tenure in the absence of PAMB and Management Plan for declared protected areas

Justification:

- NIPAS law prohibits issuance of tenurial instruments for area w/out PAMB/Management Plan such as Guin-awayan Is.
- Guin-awayan DPP has been providing electricity since 2007
- NPC has Deed of Donation with Tax Dec as Proof of Authority.

Delayed filing of application for tenurial instruments (TIs) due long (up to 2 yrs) processing time of pre-requisite permits from other agencies (NCIP, MGB, PCSD, etc)

Request

- Accept proof of application to other government agencies for pre-requisite permits/certificates of TI applications.
- Apply "Presumption of Prior Approval", principle behind EO 30 (Energy Project of National Significance) "A permitting agency acts on application on presumption that all relevant permits from other gov't agencies have been issued".

Justification

- Need to fast-track securing of permits
- Implement energy projects on time
- Electricity as basic necessity, crucial for socio-economic development

Concern No. 5



Processing duration for SAPA, FLAg and SLUP applications

Request

- Streamline tenurial instruments' requirements and/or shorten processing durations
- Consider enrolling tenurial instruments' application processes in the EVOSS.

Justification

- Previous applications took 1-2 years to secure tenurial instruments
- Need to implement urgent NPC Energy Projects on time
- Electricity as basic necessity, crucial for socio-economic development

Proof of Authority



Request

- Inclusion of energy projects in EMB MC 002-2022 Sec IV.h for projects not required to submit Proof of Authority
- Accept Deed of Donation/Sale with Tax Declaration or LGU Resolution or Authority

Justification

- MC 002-2022 rationale that government road/irrigation projects are not required to submit Proof of Authority since it has power to take private properties for public use, also applies to NPC projects
- Tax declaration is the only Proof of Authority in some areas
- Need to resolve issue re Proof of Authority for ECC applications & other permits

Concern No. 7

Immediate deployment/operation of gensets/power barges to address power shortage

Request

- Treat power shortage as emergency, w/ consideration to permit applications
- Allow transfer/operation of gensets/barges w/o penalty with submission of ff:
 - a. Letter request/notification 30 days before deployment/transfer except for extreme emergency cases
 - b. SB Resolutions/LGU certifications on 'emergency' nature on such situation
 - c. ECC/Permit applications to follow

Justification

NPC is mandated to address the power-related emergencies

Power shortage has serious repercussions to communities/LGUs



Permit application requirements

Request:

Agree on reference for requirements (Online application systems/Citizen's Charter)

Justification

- Some Regional Offices require documents not listed in the online application systems or deviate from MC:
 - a. R4B requires Proof of Authority for PTO/WDP applications, and LGU Certification that septic tank design is compliant with Code on Sanitation for WDP application;
 - b. R5 requires PCOs to attend another 40-hr Basic PCO Training for PCO accreditation renewal

EMB CO approval of clustering of NPC power facilities

Request:

 Expedite & provide timeline for evaluation/processing of request for clustering of power facilities

Justification

- Clustering of Bohol plants submitted on Sep 2023 & Mar 2024 but not yet approved.
- Clustering of San Pedro & San Pablo DPPs submitted on Sep 2023, approved on 17 Sep 2024 (duration of 1 year)
- Clustering of Panay Minigrid Plants submitted on 24 Aug 2023, approved on 19 Sep 2024
- Delayed approval on the clustering also delays securing of PCO Accreditation

Submission of Results of Laboratory Analysis for Wastewater Effluent

Request:

- Exemption from submission of BOD/Coliform results for plants that cannot comply with sample holding time
- Allow use of portable equipment as option

Justification

Some power facilities are far from DENR-recognized laboratories

Penalties/Fines



Request:

Consideration on the penalties/fines

Justification

Plant Head/PCO pays penalties since gov't does not provide budget

- Operation w/o ECC as emergency measure
- Oil spill due to force majeure
- Operation of day tanks (1-2.5kL) prior to 2020 w/o permit, not previously cited violation
