This refers to the urgent instructions of the DENR Secretary during the Executive Committee meeting held today, February 5, 2024, regarding Foreshore Area Management particularly those with existing Foreshore or Miscellaneous Lease Agreements (FLAs/MLAs), Provisional Permits, and Revocable Permits.

Please note that this matter was also discussed during the Reprogramming Workshop in Tagaytay City last January 31 to February 2, 2024.

In the said meetings, the Honorable Secretary directed the submission of the following documents and data:

- Copies of the approved/signed Foreshore/Miscellaneous Lease. Agreements, Provisional Permits, and Revocable Permits. Should the copy of the said approved Foreshore/Miscellaneous Lease Agreements no longer be available in your records, please submit a Certification to support the same. Also, you are hereby instructed to reconstruct the said documents;
- The corresponding approved Survey Plan and Tabular Technical Description of each Agreement and Permit, and the sketch plan of the approved Revocable Permits; and
- The corresponding shapefiles of all these Agreements and Permits with complete attributes, and are correctly projected. The attribute table shall contain the following information.

In view thereof, you are hereby instructed to submit the abovementioned documents and data within seven (7) working days or until February 13, 2024, to enable us to consolidate the same and to submit to the Office of the Secretary within the deadline set. Non-submission of the requested documents and data will be reflected in the report to the DENR Secretary.
