SUBMISSION OF UPDATED REGIONAL CITIZEN'S CHARTERS

Pursuant to Rule VI, Section 3 of the IRR of RA 11032, or the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", and in connection with Anti-Red Tape Authority Memorandum Circular (ARTA MC) 2019-002¹ and 2019-002-A², the existing DENR Citizen's Charter process flows shall be updated and be harmonized with the existing and applicable laws, regulations, issuances, and policies of the agency.

In line with ARTA MC 2023-08<sup>3</sup> dated 22 November 2023, all submissions of DENR Citizen's Charters (Harmonized and Regional Citizen's Charters) beginning this year shall be consolidated by the DENR Central Office (CO) CART for submission to the ARTA.
