SCHOOL OF BIOAGRICULTURAL SCIENCES (GSBS), NAGOYA
UNIVERSITY, JAPAN

This refers to the email dated 01 February 2024 of the Director and Designated Associate Professor, Mary Jean G. Bulatao of Nagoya University Asian Satellite Campus-Philippines, requesting the DENR to disseminate and nominate candidates to the abovementioned scholarship program.

The scholarship is hosted by the Graduate School of Bioagricultural Sciences (GSBS) of Nagoya University which primarily targets professionals in government positions, and academic institutions from select Asian countries who have already completed a master's degree and wish to earn a doctoral degree. This special research-based doctoral program will provide an opportunity for the participants to work towards a doctoral degree through Nagoya University without having to leave their posts.

The duration of the program is three (3) years which will **commence in October 2024**. Those who obtain the necessary credits and pass the dissertation examination will be granted a Degree of "**Doctor of Agricultural Science**" conferred upon by the Graduate School of Bioagricultural Sciences, Nagoya University.

Nagoya University will provide roundtrip economy-class airfare and accommodation for the duration of each intensive supervision seminar in Japan. The program does not request students to pay application fees, admission fees and tuition fees for the standard duration of the program.

Interested applicants shall possess the following qualification requirements of the DENR:

1. Have at least two (2) years holding permanent plantilla position in the DENR at the time of application;
2. Have obtained performance ratings of at least Very Satisfactory for the last two (2) consecutive rating periods;
3. Performing duties and responsibilities relevant to the field of study/travel being applied for. For this case, applicants are preferably have at least two (2) years work experience in forestry, fishery and agriculture;
4. Have no pending administrative case;
5. Have no pending application and nomination for other study and non-study trips;
6. Have not exceeded four (4) official foreign travel within a year;
7. Have submitted all the required reports from previous foreign travels
8. Have rendered the required service obligation for a scholarship previously enjoyed;

9. Must be willing to conduct a master's thesis aligned to the priority programs of the Department or related topics to be identified/approved by the DENR;
10. Must be willing to sign a scholarship service contract and shall serve the DENR with the corresponding period of service obligation; and
11. Must not be a delinquent scholar.

The nominee shall submit complete application requirements to the Career Development Division through this link bit.ly/nomiforeign on or before 01 May 2024:



1. Memorandum addressed to the Chair of the Human Resource Development Committee (HRDC), attention HRDC Secretariat to be endorsed by Head of Office and concurred by Supervising Undersecretary and Assistant Secretary;
2. Resolution from HRDC Counterpart recommending the nomination of the applicant;
3. Service Record;
4. Certificate of no pending administrative case;
5. Certification from the Director supervising human resources/Assistant Regional Director for Management Service/Assistant Director (Region/Bureau/Attached Agency) stating that the applicant:
 - a. has no pending scholarship nomination;
 - b. has not been a delinquent scholar from a previous scholarship grant;
 - c. has submitted all the required reports from previous foreign travels;
 - d. has performance ratings of at least Very Satisfactory for the last two (2) consecutive rating periods;
6. Updated Personal Data Sheet, with Work Experience Sheet, duly signed by authorized person administering oath; and
7. Self Certification of official Travel History for the past 24 months.

The DENR HRDC shall screen and select qualified candidates to the program. Application period is from June 18, 2024 and June 21, 2024. Selected candidates will be notified and endorsed to proceed with the online application at GSBS: <https://www.agr.nagoya-u.ac.jp> and submission of the attached list of requirements.

I 制度の概要

I OUTLINE

1. 目的

アジア諸国の国家中枢人材養成プログラムは、既に修士の学位を有し、博士の学位の取得を希望するアジア諸国の政府幹部又はこれに準ずる人材に対して、本学本邦キャンパスと連携した名古屋大学アジアサテライトキャンパスでの教育及び本邦キャンパスでの短期集中研究指導を組み合わせた質の高い教育により、現職を維持したまま、その経験と知識を深化させることを目的とした博士後期課程プログラムである。

1. Objectives

The Transnational Doctoral Programs for Leading Professionals in Asian Countries aim to offer doctoral degrees to government executives or individuals serving in equivalent leading positions of Asian countries who already possess a master's degree and wish to continue their studies, by providing a quality education program which combines education at Nagoya University (NU) Asian Satellite Campuses conducted in collaboration with NU's main campus, and short-term intensive academic activities at main campus in Japan enabling students to continue their carrier in the current posts while deepening their knowledge and experience.

(1) 基本的考え方

(1) Basic Concepts

各分野のナショナル・リーダー育成に相応しいもので、ICTを活用した遠隔での日常的な研究指導、一定期間の本邦キャンパスでの修学（スクーリング）における集中講義、研究指導、論文作成の指導及び、名古屋大学アジアサテライトキャンパスでの指導を行う。

The curriculum is suitable for nurturing national leaders in various fields, providing day-to-day remote research guidance through active use of ICT. There will be fixed schooling sessions consisting of intensive lectures, seminars, research guidance and thesis writing guidance on NU's Japanese domestic campuses, and research guidance at the Nagoya University Asian Satellite Campuses.

II APPLICATION GUIDELINES

名古屋大学大学院生命農学研究科は、農学ないし関連分野の修士課程を修了し、現在、政府および中枢機関において政策立案業務に従事している職員、あるいは政府関連試験研究機関等で研究・技術開発業務に従事している社会（職業）人および大学教員に対して、それまで蓄積してきた経験の理論化ならびに知識の深化・高度化の機会を提供するために、博士後期課程入学のための特別選抜制度を下記のとおり実施する。

The Graduate School of Bioagricultural Sciences, Nagoya University, will carry out a special selection of promising candidates for admission to our doctoral program. This is exclusively for government officials engaged in policy making, researchers or technical staff at government institutions working on conducting research and developing technologies, and faculty members of university.

Applicants must have graduated from a master's program. This program offers opportunities for such persons to deepen and systematize the knowledge and experience they have accumulated so far.

3. Scholarships (Schooling)

本プログラムの一環として、本邦キャンパスにおいて一定期間の修学(スクーリング)を行う際に以下の(1)、(2)及び(3)の修学支援を行う。

This Program offers learning support as detailed in (1), (2), and (3) below for the fixed learning (schooling) periods on NU's Japanese domestic campuses.

Nagoya University will provide an economy-class airplane ticket (return) from the international airport nearest the student's home address to Central Japan International Airport for students visiting Japan to take part in schooling.

(3) 滞在中の宿舎

(3) Accommodation for the duration of each intensive supervision seminar in Japan will be provided for the student. (Utilities shall be paid by the student).

- ④ 派遣国政府・機関等の要請があるとき。

(Note) A scholarship will be terminated if grantees fall under one of the following circumstances:

- ① If it becomes definitive that the grantee will not be able to complete his/her program within the standard duration of studies because of his/her poor academic achievement or suspension.
- ② If he/she is provided with another scholarship (except scholarships designated for research expenses).
- ③ If he/she is enrolled in another PhD course of other institutions.
- ④ If a request is received from the government and/or other state institution of the grantee's home country.

In addition, grantees who continued receiving stipend despite one of the mentioned conditions may be required to return the money received during the period in question.

Applicants with disabilities or other special needs that require reasonable

- 2) Medical certificate, any certificates of your disability (e.g., “Shogaisya-techo” in Japan), etc.: Applicants must submit Medical Certificates or other alternative documentation that provides detailed information regarding the limitation on major life activities caused by the disabilities or other special needs and provides sufficient justification for the requested accommodations or adjustments. - 3) Third Party Statements: Applicants must obtain and submit statements from third parties that are familiar with the applicant’s disabilities or special needs and can attest to the resulting limitation on major life activities and required accommodations (Observations and opinions from medical professionals, relevant faculty from the applicant’s school, and other specialists)
- 4) Other Documents: Applicants may, if desired, submit additional documentation providing additional information regarding their disabilities or other special needs and the recommended accommodations or adjustments.
