This refers to the final draft Assessment Report on the Climate Change Adaptation, Mitigation, Disaster Risk Reduction (CCAM-DRR) Roadmap 2018-2022 to Climate and Disaster Resiliency Roadmap 2023-2030 through the Technical Assistance from Asian Development Bank (ADB) – Disaster Resilience Improvement Program (ADB-DRIP).

The purpose of this Assessment is to review the Progress Monitoring Report of the CCAM-DRR Cabinet Cluster member-agencies vis-à-vis the CCAM-DRR Roadmap. By focusing on core sector issues, the analysis aims to illuminate the CCAM-DRR Roadmap's approach to key CCAM-DRR challenges within the designated period. This will highlight advancements along the CCAM-DRR Roadmap's four broad policy goals (outcomes), while identifying sectors necessitating strategic policy interventions. Review of challenges in the implementation of the CCAM-DRR Roadmap will help identify gaps and areas for improvement that will inform the mainstreaming of CCAM-DRR into the Philippines' development planning process and its economy and alignment with the National

Adaptation Plan (NAP) and the Nationally Determined Contribution Implementation Plan (NDC IP).
