
- A. Awards for Outstanding Work Performance
 - 1. Presidential *Lingkod Bayan* Award
 - 2. CSC *Pagasa* Award
- B. Award for Exemplary Conduct and Ethical Behavior
 - 1. Outstanding Public Officials and Employees Award or *Dangal ng Bayan* Award

The HAP covers all officials and employees holding permanent, temporary, coterminous, contractual and casual status of employment, whether stationed in the Philippines or abroad. Posthumous nominations may also be made for a public servant who died in the line of duty or in pursuit of his/ her official duties and responsibilities as a civil servant.

The guidelines, nomination forms and other promotional materials can be downloaded at www.csc.gov.ph. Nominations shall be reviewed and endorsed by respective regional/ bureau Committees on PRAISE. Recommended nominations with complete documentary requirements, together with the *Checklist of Required Nomination Documents* sheet, shall be submitted on or before **29 February 2024** to the Personnel Division, DENR Central Office, for approval of the Secretary.

To acknowledge the outstanding contribution, achievements and performance of our coworkers, we urge you to nominate qualified officials and employees in our Department.

The 2024 Honor Awards Program (HAP) through the Search for Outstanding Government Workers officially commenced with the issuance of the Civil Service Commission (CSC) Memorandum Circular No. 11, s. 2023.

All officials and employees in the career and non-career service of the government are qualified to join the Search. In addition, posthumous nominations may be made for a public servant who died in the line of duty or in the pursuit of his/her official duties and responsibilities as a civil servant. Said nomination should be formalized within 12 months from the time of death of the government official or employee.
