**A RESOLUTION APPROVING THE PROVISION OF FUNDING SUPPORT FROM
THE NATIONAL DRRM FUND TO ALL LGUs FOR THE REPAIR,
RECONSTRUCTION OR REHABILITATION OF LOCAL OR NATIONAL
INFRASTRUCTURE REGARDLESS OF INCOME CLASSIFICATION**

NDRRM RESOLUTION NO. 01, s. 2024

WHEREAS, Section 22 of the Republic Act No. 10121 provides that the National DRRM Fund shall be used for disaster risk reduction or mitigation, prevention and preparedness activities, such as, but not limited to, training of personnel, procurement of equipment, and capital expenditures. It can also be utilized for relief, recovery, reconstruction, and other work or services in connection with natural or human-induced calamities which occur during the budget year or those that occurred in the past two (2) years from the year;

WHEREAS, the same provision of the law further provides that the specific amount of the National DRRM Fund and the appropriate recipient agencies and/or LGUs shall be determined upon approval of the President of the Philippines in accordance with the favorable recommendation of the National DRRM Council;

WHEREAS, the FY-2024 General Appropriations Act, Republic Act No. 11975, provides for an allocation of the NDRRM Fund in the amount of PhP 19,500,000,000.00 that can be utilized for "reconstruction, rehabilitation, repair of essential infrastructures such as, but not limited, to bridges and roads, schools and multi-purpose buildings, aid, relief and other works or services..."


WHEREAS, the NDRRMC Memorandum Circular No. 01, series of 2024 prioritized 4th to 6th Class LGUs and Annexes 4.B (Requirements for Early Recovery Interventions) and 5.B (Requirements for Rehabilitation and Reconstruction) requires a Local Counterpart Fund for 1st to 3rd Income Class LGUs to access the NDRRM Fund;


WHEREAS, the National DRRM Council met on February 13, 2024 and agreed that due to the severity of the effects of the disasters depleting the limited resources of LGUs, support from the national government is critical to ensure resilient recovery of disaster affected areas;

NOW, THEREFORE, the National DRRM Council **RESOLVES** as it is hereby **RESOLVED** that the NDRRMC MC 01. Series of 2024 Annexes 4.B and 5.B prioritizing only 4th to 6th Income Class LGUs and requiring 1st to 3rd Income Class for a Local Counterpart Fund be repealed. The NDRRM Fund may be utilized to repair, reconstruct or rehabilitate whether local or national infrastructure regardless of income classification when such are vital for access and connectivity and are necessary for response or early recovery as certified by the Regional Directors of the OCD and the DPWH in disaster-affected regions.

RESOLVED FINALLY, that the Chairperson, NDRRMC is hereby authorized to sign this Resolution for and on behalf of the members.
