an Inter-Agency Joint Memorandum Circular

Dear Undersecretary FRAGADA:

Thank you for your agency's participation during the 8th Meeting of the Technical Work Group (TWG) of land title-issuing agencies held last 20 February 2024. The participation of your office is vital to the TWG's aim of reconciling and standardizing systems and processes among land title-issuing agencies and thereby, addressing the gaps and shortfalls in the land registration proceedings in the country.

To ensure the continuity of the discussion on the proposed review and harmonization of the existing issuances by and between the member agencies, may we invite you and/or your authorized representatives to the 9th Meeting of the TWG scheduled on 21 March 2024, Thursday, 10:00 A.M. at the Hall of Justice, Delas Alas Bidg., Department of Justice, Padre Faura, Manila.

Participant agencies will provide updates regarding their commitments during the last meeting, namely:

1) National Commission on Indigenous Peoples (NCIP) committed to submit the remaining shapefiles of all issued Certificates of Ancestral Land Titles (CALTs) by 28 February 2024;

 Department of Environment and Natural Resources (DENR) committed to update the list of Presidential Proclamations sent to the Land Registration Authority (LRA) to include lot numbers and other land identification details;

3) Land Management Bureau (LMB) committed to determine the total area of "intersections" based on National Mapping and Resource Information Authority (NAMRIA) submissions;

4) LRA committed to derive shapefiles of individual Certificate of Land Ownership Awards (CLOAs) within two (2) weeks from the last TWG meeting or by the first week of March 2023; and

5) LRA committed to plot Presidential Proclamations with Technical Descriptions.

Thereafter, per agreement of the members of the TWG, the plenary will discuss the draft Joint Memorandum Circular (JMC) focusing on the provisions pertaining to titles issued prior to the enactment of the Indigenous People's Rights Act (IPRA).
